### **ATISN 14524 - Covid 19 Caerphilly Local Lockdown**

Thank you for your request which I received on 8 November. You asked for the following information:

**A copy of the "*Impact Assessment*" undertaken to inform the ministerial lockdown decision.**

On 8 September, the Welsh Ministers - following meetings with local authority leaders and other public authorities - agreed to establish a Local Health Protection Area (LHPA) in the County Borough of Caerphilly because of the emergency situation emerging in the Borough. This decision was supported by the Chief Medical Officer and followed the advice of the Aneurin Bevan Health Board. At the time the decision was made Caerphilly had the highest incidence rate of coronavirus in Wales, which was growing more quickly than any other part of Wales.

An impact assessment was not prepared in relation to these regulations due to the need to put them in place urgently as part of the ongoing response to a serious and imminent threat to public health. The Welsh Government has published a series of impact assessments on coronavirus, including the evidence of socio-economic and equality impacts of restrictions considered by Welsh Ministers (<https://gov.wales/impact-assessments-coronavirus>). This includes an integrated impact assessment covering social gathering and travel (<https://gov.wales/summary-restrictions-social-gathering-and-travel-business-closures-and-attendance-school>) which were principal restrictions introduced in Caerphilly.

The rising risks of Covid related health impacts were balanced against the social and economic impact of restrictions with financial support put in place for businesses suffering hardship.
