Title, commencement and application

- 1.—(1) The title of these Directions is the Primary Medical Services (Provision of Essential General Medical Services over the Christmas and New Year Period during the COVID-19 Pandemic) (Directed Enhanced Service) (Amendment) Directions 2020.
- (2) These Directions come into force on 16 December 2020.
- (3) These Directions are given to Local Health Boards.

- **2.**—(1) The Primary Medical Services (Provision of Essential General Medical Services over the Christmas and New Year Period during the COVID-19 Pandemic) (Directed Enhanced Service) Directions 2020 are amended as follows.
 - (2) In Direction 4, sub-paragraph (4)(b)—
 - (a) in paragraph (i), after "£275" insert "for every 1000 patients on the practice registered patient list";
 - (b) in paragraph (ii), after "£150" insert "for every 1000 patients on the practice registered patient list";
 - (c) in paragraph (iii), after "£165" insert "for every 1000 patients on the practice registered patient list";
 - (d) in paragraph (iv), after "£85" insert "for every 1000 patients on the practice registered patient list";
 - (e) in paragraph (v), after "£165" insert "for every 1000 patients on the practice registered patient list"; and
 - (f) in paragraph (vi), after "£85" insert "for every 1000 patients on the practice registered patient list".
 - (3) In the Schedule, after paragraph 14(b) insert—

"(ba) Monday, 28 December 2020, between the hours of 8:00 and 13:15 (5.25 hours),".
