**Information requested**

You asked for the following information:

1. The number of times CIW has received a notification from a Local Authority of a young person being placed in an unregistered care home service from 1 April 2020 up 30 November 2020.
2. The number of times CIW has received a notification from a Local Authority of a young person being placed in an unregistered care home service from 1 April 2019 to 30 November 2019.

1. During the period 1 April 2020 to 30 November 2020, CIW were notified of 15 young people being placed in an unregistered care home service in Wales.
