In line with the Welsh Government Retention Policy, all personal sensitive information will be kept for 10 years from receipt of the EIA Application Form. When we no longer need to retain your information we will ensure that it is securely disposed of. Any personal data will not be published on the public register.

Non personal data will be retained and also made available on the public register for at least 20 years. After 20 years a review will be undertaken to determine whether the information is still relevant. If so, we will retain it. When we no longer need to retain your information we will ensure that it is securely disposed of.
