- (b) adeiladu a gwella priffyrdd a darparu mynedfeydd newydd i fangreoddd o gyffordd ddwyreiniol Cylchfan Penblewin hyd at bwynt ger yr eiddo o'r enw Jacob's Lodge yn y Cymunedau a enwyd, yn y Sir a enwyd, yn unol â Gorchymyn Cefnffordd Llundain i Abergwaun (yr A40) (Gwelliant Penblewin i Redstone Cross) (Ffyrdd Ymyl) 2021;

**COMPULSORY PURCHASE OF LAND AND  
NEW RIGHTS BETWEEN PENBLEWIN AND  
REDSTONE CROSS**

The Welsh Ministers have, on the 24 March 2021, made The Welsh Ministers (The London to Fishguard Trunk Road (A40) (Penblewin to Redstone Cross Improvement)) Compulsory Purchase Order 2021, under sections 239, 240, 246, 250 and 260 of the Highways Act 1980 and under section 2 of, and paragraph 1(1)(b), (3) and (4) of Part 1 of Schedule 2 to, the Acquisition of Land Act 1981. The Welsh Ministers are about to make this Order and if made the Order will authorise the Welsh Ministers to purchase compulsorily the land and new rights described below for the purpose of—

- (a) the construction of a new trunk road from the eastern junction of the Penblewin Roundabout in the Community of Llanddewi Velfrey in the County of Pembrokeshire to a point on the A40 adjacent to the property known as Jacob's Lodge in the Community of the Town of Narberth in the County of Pembrokeshire, in pursuance of the London to Fishguard Trunk Road (A40) (Penblewin to Redstone Cross Improvement and De-trunking) Order 2021;
- (b) the construction and improvement of highways and the provision of new means of access to premises from the eastern junction of the Penblewin Roundabout to adjacent to the property known as Jacob's Lodge in the said Communities, in the said County, in pursuance of the London to Fishguard Trunk Road (A40) (Penblewin to Redstone Cross Improvement) (Side Roads) Order 2021;
- (c) the improvement of the trunk road, in the said Communities in the said County;
- (d) the execution of works on watercourses in connection with the construction of the new trunk road and the construction and improvement of other highways and the execution of other works mentioned above;

- (f) eu defnyddio gan Weinidogion Cymru mewn cysylltiad â'r gwaith gwella priffyrdd hwnnw a gwneud y gwaith arall a grybwyllir uchod; ac

If any person aggrieved by the CPO desires to question the validity of the Order, or of any of the provisions contained therein, on the ground that:

a. the authorisation of a compulsory purchase thereby granted is not empowered to be granted under the Acquisition of Land Act 1981 or any such enactment as is mentioned in section 1(1) of the Act; or

b. any relevant requirement has not been complied with,

that person may, within 6 weeks of it becoming operative make an application to the High Court.
