Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A55, wedi eu bodloni y dylid gwahardd traffig a/neu gyfyngu arno ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A55 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A55 (Cyffordd 12 (Tal-y-bont) i Gyffordd 13 (Abergwyngregyn), Gwynedd) (Cyfyngiad a Gwaharddiadau Traffig Dros Dro) 2021 a daw'r Gorchymyn hwn i rym ar 27 Mawrth 2021.

1. The title of this Order is the A55 Trunk Road (Junction 12 (Tal-y-bont) to Junction 13 (Abergwyngregyn), Gwynedd) (Temporary Traffic Restriction & Prohibitions) Order 2021 and this Order comes into force on 27 March 2021.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, na pheri na chaniatáu i unrhyw gerbyd fynd drwy'r bylchau yn llain ganol y darnau o'r gefnffordd a bennir yn Atodlen 2 i'r Gorchymyn hwn.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, ddefnyddio cerbyd na chaniatáu i gerbyd gael ei ddefnyddio yn y fath fodd fel ei fod yn goddiweddyd unrhyw gerbyd arall ar y darn o'r gefnffordd a bennir yn Atodlen 1 i'r Gorchymyn hwn ar yr adegau hynny pan fo'r cyfyngiad y cyfeirir ato yn erthygl 3 yn weithredol.

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A55 Chester to Bangor trunk road;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on 27 March 2021 and ending when the temporary traffic signs are permanently removed.

Restriction and Prohibitions

3. No person may, during the works period, drive any motor vehicle at a speed exceeding 10 miles per hour on the length of the trunk road specified in Schedule 1 to this Order.

4. No person may, during the works period, drive or cause or permit any vehicle to proceed through the gaps in the central reservation of the lengths of the trunk road specified in Schedule 2 to this Order.

5. No person may, during the works period, use or permit the use of a vehicle in such a way that it overtakes any other vehicle on the length of the trunk road specified in Schedule 1 to this Order during such times as the restriction referred to in article 3 is in operation.

8. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

6.—(1) The restriction and prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limit imposed by this Order applies to an exempted vehicle.

Suspension

7. Any statutory provisions restricting the speed of vehicles on the length of the trunk road specified in Schedule 1 to this Order are suspended during such times as the restriction specified in article 3 is in operation.

Duration of this Order

8. The maximum duration of this Order is 18 months.

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A55, neu gerllaw iddi, rhwng Cyffordd 12 (Tal-y-bont) a Chyffordd 13 (Abergwyngregyn), Gwynedd.

Effaith y Gorchymyn yw gwneud y canlynol dros dro:

**THE A55 TRUNK ROAD (JUNCTION 12 (TAL-Y-BONT) TO JUNCTION 13
(ABERGWYNGREGYN), GWYNEDD)
(TEMPORARY TRAFFIC RESTRICTION &
PROHIBITIONS) ORDER 2021**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A55 trunk road between Junction 12 (Tal-y-bont) and Junction 13 (Abergwyngregyn), Gwynedd.

The effect of the Order is to temporarily:


- i. impose a 10 mph speed limit on the length of the A55 trunk road specified in Schedule 1 to this Notice. This speed limit will only apply during convoy working and no overtaking will be permitted at these times;
- ii. prohibit the movement of traffic through the gaps in the central reservation of the lengths of the A55 trunk road specified in Schedule 2 to this Notice.

The Order comes into force on 27 March 2021. The temporary restriction and prohibitions are expected to come into force on that date and will operate overnight (20:00 – 06:00 hours) until 31 March 2021 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the period specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
