**COMPULSORY PURCHASE OF LAND AND
NEW RIGHTS AT PENMAENMAWR**

The Welsh Ministers have prepared in draft The Welsh Ministers (The Chester to Bangor Trunk Road (A55) (Junctions 16 and 16a Improvement Realignment and Slip Roads)) Compulsory Purchase Order 202-, under sections 239, 240, 246, 250 and 260 of the Highways Act 1980 and under section 2 of, and paragraph 1(1)(b), (3) and (4) of Part 1 of Schedule 2 to, the Acquisition of Land Act 1981. The Welsh Ministers are about to make this Order and if made the Order will authorise the Welsh Ministers to purchase compulsorily the land and new rights described below for the purpose of—

- (a) the construction of the new trunk road, slip roads and overbridge from a point on the trunk road 508 metres south west of the centre point of the existing Junction 16 (Puffin Roundabout) in the Community of the Town of Penmaenmawr in the County Borough of Conwy to a point on the trunk road 315 metres north east of its existing Junction 16A with Glan-Yr-Afon Road, in the Community of the Town of Penmanemawr in the County Borough of Conwy, in pursuance of the Chester to Bangor Trunk Road (A55) (Junctions 16 and 16A Improvement Realignment and Slip Roads) Order 202-;
- (b) the construction and improvement of highways and the provision of new means of access to premises from 625 metres south west of the centre point of the existing Junction 16 (Puffin Roundabout) in the Community of the Town of Penmaenmawr in the County Borough of Conwy to a point on the trunk road 315 metres north east of the north eastern side of its existing Junction 16A with Glan-Yr-Afon Road, in the said Community in the said County Borough, in pursuance of the Chester to Bangor Trunk Road (A55) (Junctions 16 and 16A Improvement Realignment and Slip Roads) (Side Roads) Order 202-;

- (d) darparu adeiladau a chyfleusterau i'w defnyddio mewn cysylltiad ag adeiladu, defnyddio a chynnal y gefnffordd;
- (e) gwneud gwaith ar gyrsiau dŵr mewn cysylltiad ag adeiladu'r gefnffordd ac adeiladu a gwella priffyrdd eraill a gwneud y gwaith arall a grybwyllir uchod;
- (f) eu defnyddio gan Weinidogion Cymru mewn cysylltiad â'r gwaith gwella priffyrdd hwnnw a gwneud y gwaith arall a grybwyllir uchod; ac
- (g) lliniaru unrhyw effeithiau andwyol a fydd gan fodolaeth neu ddefnydd unrhyw un neu ragor o'r priffyrdd y cynigir eu hadeiladu a'u gwella ar eu hamgylchoedd.

- (f) use by the Welsh Ministers in connection with such improvement of highways and the execution of other works mentioned above; and
- (g) the mitigation of any adverse effects which the existence or use of certain of the highways proposed to be constructed and improved will have on the surroundings thereof.


