Thank you for the update in your letter dated 28th September 2020, of which we have noted the contents.

Please be advised that we will be refunding any parking or executive lounge bookings made directly on the Cardiff Airport website for passengers living in Llanelli town, Swansea, Cardiff, Neath Port Talbot, Torfaen and the Vale of Glamorgan who are not able to travel due to the localised lockdown. However, we do remain open for travel for eligible customers.

We advise our customers to check the relevant guidance before travel and determine whether they are permitted to leave the area and have a legitimate reason to fly. This is not for the Airport to determine.

We continue to follow the guidance in place by Public Health Wales keeping the safety and security of our team and customers our number one priority.
