

DEDDF CYNLLUNIO GWLAD A THREF 1990

GORCHYMYN CAU PRIFFYRDD (TIR I'R DE-DDWYRAIN O LÔN CAE DARBI, YSTÂD DDIWYDIANNOL CIBYN, CAERNARFON, GWYNEDD) 2021

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (LAND LOCATED SOUTH EAST OF LÔN CAE DARBI, CIBYN INDUSTRIAL ESTATE, CAERNARFON, GWYNEDD) ORDER 2021

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The stopping up will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Council on 27 September 2018 under reference number C18/0565/14/LL, as amended by planning permission reference number C19/0190/14/LL on 30 April 2019 and described in Schedule 2 to this Order.

The Stopping Up of Highways (Land Located South East of Lôn Cae Darbi, Cibyn Industrial Estate, Caernarfon, Gwynedd) Order 2020 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge at Datrys Engineering, Unit 6 Block A, Doc Fictoria, Caernarfon, LL55 1TH during normal office hours or may be obtained free of charge from the address below quoting reference qA1404020.

If a person is aggrieved by the Order, on the ground that:

a. it is not within the powers of the 1990 Act; or

b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 25 August 2021 make an application for the purpose to the High Court.

A rectangular shaped length of highway, with a maximum length of 13.12 metres and a maximum width of 11.26 metres located southeast of its junction with Lôn Cae Darbi as shown by zebra hatching on the deposited plan.
