Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A55, wedi eu bodloni y dylid gwahardd traffig a/neu gyfyngu arno ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the A55 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited and/or restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddwyd iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A55 (Twunnel Penmaen-bach, Bwrdeistref Sirol Conwy) (Gwaharddiadau a Chyfyngiadau Traffig Dros Dro) 2021 a daw'r Gorchymyn hwn i rym ar 13 Medi 2021.

1. The title of this Order is the A55 Trunk Road (Penmaenbach Tunnel, Conwy County Borough) (Temporary Traffic Prohibitions & Restrictions) Order 2021 and this Order comes into force on 13 September 2021.

Interpretation

“exempted vehicle” (“*cerbyd esempt*”) means:

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy'n dechrau am 19:00 o'r gloch ar 13 Medi 2021 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A55 Caer i Fangor.

Gwaharddiadau a chyfyngiadau

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar gerbyttffordd tua'r dwyrain neu gerbyttffordd tua'r gorllewin y darn o'r gefnffordd a bennir yn Atodlen 1 i'r Gorchymyn hwn.

4.—(1) Tra bo cerbydau wedi eu gwahardd gan erthygl 3 rhag symud ar y gerbyttffordd tua'r dwyrain, ond yn unol ag erthygl 12, heb eu gwahardd ar y gerbyttffordd tua'r gorllewin, ni chaiff neb yrru unrhyw gerbyd modur er mwyn peri neu ganiatáu iddo:

- (a) mynd ar lôn allanol y gerbyttffordd tua'r gorllewin i unrhyw gyfeiriad ac eithrio tua'r dwyrain;

- (a) any vehicle being used for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1); and
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
 - (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds; or
 - (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A55 Chester to Bangor trunk road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 13 September 2021 and ending when the temporary traffic signs for each period of works are removed.

Prohibitions and restrictions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on either the eastbound or westbound carriageways of the length of the trunk road specified in Schedule 1 to this Order.

4.—(1) Whilst vehicle movement is, by article 3, prohibited on the eastbound carriageway, but pursuant to article 12, not prohibited on the westbound carriageway, no person may drive so as to cause or permit any motor vehicle to:

- (a) proceed in the offside lane of the westbound carriageway in any direction other than eastwards;

10. Ni chaiff neb, yn ystod cyfnod y gwaith, reidio unrhyw feic pedal ar y darn o'r gefnffordd a bennir yn Atodlen 8 i'r Gorchymyn hwn.

11. Ni chaiff neb, yn ystod cyfnod y gwaith, gerdded ar y darn o'r gefnffordd a bennir yn Atodlen 8 i'r Gorchymyn hwn.

Cymhwyso

12.—(1) Ni fydd y gwaharddiadau a'r cyfyngiadau yn erthyglau 3, 4, 5, 6, 7, 8, 9, 10 ac 11 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y'u

- (b) proceed in any direction other than eastwards through either of the gaps in the central reservation of the length of the trunk road specified in Schedule 3 to this Order.

(2) Whilst vehicle movement is, by article 3, prohibited on the westbound carriageway, but pursuant to article 12, not prohibited on the eastbound carriageway, no person may drive so as to cause or permit any motor vehicle to:

- (a) proceed in the offside lane of the eastbound carriageway in any direction other than westwards;
- (b) overtake any motor vehicle on the length of the trunk road specified in Schedule 2 to this Order;
- (c) proceed in any direction other than westwards through either of the gaps in the central reservation of the length of the trunk road specified in Schedule 3 to this Order.

5. No person may, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the length of the trunk road specified in Schedule 4 to this Order.

6. No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in Schedule 5 to this Order.

7. No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of the trunk road specified in Schedule 6 to this Order.

8. No person may, during the works period, cause or permit any vehicle with a width of or exceeding 3.2 metres or 3.7 metres to proceed on the lengths of the trunk road specified in Schedule 7 to this Order.

9. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the trunk road specified in Schedule 5 to this Order.

10. No person may, during the works period, ride any pedal cycle on the length of the trunk road specified in Schedule 8 to this Order.

11. No pedestrian may, during the works period, proceed on the length of the trunk road specified in Schedule 8 to this Order.

Application

12.—(1) The prohibitions and restrictions in articles 3, 4, 5, 6, 7, 8, 9, 10 and 11 apply only at such times and to such extent as indicated by traffic signs.

Suspensions

13. The provisions of The Trunk Road (A55) (Penmaenbach - Dwygyfylchi, Gwynedd) (One-Way Traffic) Order 1990(1) are suspended insofar as they relate to the offside lane of the westbound carriageway of the length of the trunk road specified in Schedule 1 to this Order during such times as the eastbound carriageway is closed in accordance with article 3 and to the offside lane of the eastbound carriageway of the length of the trunk road specified in Schedule 1 to this Order during such times as the westbound carriageway is closed in accordance with that article.

14. The provisions of The A55 Trunk Road (Penmaenbach Tunnel, Gwynedd) (Closure of Central Reservation Crossings) Order 1994(2) are suspended during such times as the prohibition specified in article 3 is in operation.

15. Any statutory provisions restricting or derestricting the speed of vehicles on the relevant lengths of the trunk road specified in Schedules 4, 5 and 6 to this Order are suspended during such times as the restrictions specified in articles 5, 6 and 7 are in operation.

Duration of this Order

16. The maximum duration of this Order is 18 months.

No overtaking restriction

The length of the eastbound (headland) carriageway of the trunk road that extends from a point 320 metres west of the western portal of the Penmaenbach Westbound Tunnel to a point 130 metres east of the eastern portal of that tunnel.

SCHEDULE 3
Limits of the central reserve gaps

The gap in the central reservation situated between a point 130 metres east of the eastern portal of the Penmaenbach Westbound Tunnel and a point 65 metres east of that portal.

The gap in the central reservation situated between a point 210 metres west of the western portal of the Penmaenbach Westbound Tunnel and a point 320 metres west of that portal.

SCHEDULE 4
Temporary 50 mph speed limit

The length of the westbound carriageway of the trunk road that extends from a point 20 metres east of the eastern portal of the Conwy Tunnel to a point 20 metres west of the centre-point of Morfa Drive over-bridge.

SCHEDULE 5
Temporary 40 mph speed limit & prohibition of vehicles

The length of the westbound carriageway of the trunk road that extends from a point 500 metres east of the centre-point of the Junction 19 (Glan Conwy Interchange) roundabout to the centre-point of Red Gables Viaduct over-bridge, including the westbound entry and exit slip roads at Junctions 19, 18, 17, the roundabout at Junction 16 and the central reserve gap as defined in paragraph 2 of Schedule 3.

Extension of the Headland 30mph speed restriction

The length of the central reserve gap between a point 130 metres east of the eastern portal of the Penmaenbach Westbound Tunnel and a point 65 metres east of that portal.

The length of the westbound carriageway of the trunk road that extends from a point 840 metres west of the centre-point of the Junction 17 (Conwy Morfa) over-bridge to a point 362 metres west of the western portal of the Penmaenbach Westbound Tunnel.

The length of the eastbound carriageway of the trunk road that extends from a point 940 metres east of the centre-point of Junction 16 (Puffin Roundabout) to a point 191 metres west of the western portal of Penmaenbach Eastbound Headland Tunnel.

The gap in the central reservation between a point 210 metres west of the western portal of the Penmaenbach Westbound Tunnel and a point 320 metres west of that portal.

SCHEDULE 7

Vehicle width restriction

The length of the westbound carriageway of the trunk road that extends from the nosing of the westbound exit slip road at Junction 18 (Llandudno Junction Interchange) to a point 30 metres east of the centre-point of Junction 16 (Puffin Roundabout), including the westbound entry slip road at Junction 18.

The length of the eastbound carriageway of the trunk road that extends from a point 30 metres east of the centre-point of Junction 16 (Puffin Roundabout) to the nosing of the eastbound entry slip road at Junction 18 (Llandudno Junction Interchange).

SCHEDULE 8

Temporary prohibition of cyclists and pedestrians

The length of the cycleway/footpath that extends from a point 787 metres east of the eastern portal of the Penmaenbach Eastbound Headland Tunnel, including the length of cycleway/footpath adjacent to the Junction 17 eastbound exit slip road, to its abutment with the A457 at the end of that slip road.
