Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o draffordd yr M4, wedi eu bodloni y dylid gwahardd traffig ar ddarnau penodedig o'r draffordd oherwydd gwaith y bwriedir ei wneud ar y draffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the relevant length of the M4 motorway, are satisfied that traffic on specified lengths of the motorway should be prohibited because of works proposed on or near the motorway.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. Enw'r Gorchymyn hwn yw Gorchymyn Traffordd yr M4 (Cyffordd 34 (Meisgyn), Rhondda Cynon Taf i Gyffordd 49 (Pont Abraham), Sir Gaerfyrddin) (Gwahardd Cerbydau Dros Dro) 2021 a daw'r Gorchymyn hwn i rym ar 24 Medi 2021.

1. The title of this Order is the M4 Motorway (Junction 34 (Miskin), Rhondda Cynon Taf to Junction 49 (Pont Abraham), Carmarthenshire) (Temporary Prohibition of Vehicles) Order 2021 and this Order comes into force on 24 September 2021.

**Interpretation**

2. Yn y Gorchymyn hwn—

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw unrhyw gerbyd sy’n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â’r gwaith sy’n arwain at y Gorchymyn hwn;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 20:00 o’r gloch ar 24 Medi 2021 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “y draffordd” (“*the motorway*”) yw traffordd yr M4 Llundain i Dde Cymru.

### **Gwaharddiad**

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darnau o’r cerbyttfyrdd tua’r gorllewin a thua’r dwyrain o draffordd yr M4 rhwng Cyffordd 34 (Meisgyn), Rhondda Cynon Taf a Chyffordd 49 (Pont Abraham), Sir Gaerfyrddin, gan gynnwys yr holl ffyrdd ymadael ac ymuno tua’r gorllewin a thua’r dwyrain rhwng y cyffyrdd hyn.

### **Cymhwyso**

4. Nid yw’r gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

### **Cyfnod para’r Gorchymyn hwn**

5. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

“the motorway” (“*y draffordd*”) means the M4 London to South Wales motorway;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 20:00 hours on 24 September 2021 and ending when the temporary traffic signs for each period of works are removed.

### **Prohibition**

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the lengths of the westbound and eastbound carriageways of the motorway between Junction 34 (Miskin), Rhondda Cynon Taf and Junction 49 (Pont Abraham), Carmarthenshire, including all westbound and eastbound exit and entry slip roads between these junctions.

### **Application**

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

### **Duration of this Order**

5. The maximum duration for this Order is 18 months.
