

DEDDF CYNLLUNIO GWLAD A THREF 1990

GORCHYMYN CAU PRIFFYRDD (FFORDD CAMBRIA, PORTHAETHWY, YNYS MÔN) 2021

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 247 o Ddeddf Cynllunio Gwlad a Thref 1990 ("Deddf 1990") i awdurdodi cau'r darn o briffordd a ddisgrifir yn Atodlen 1 i'r Hysbysiad hwn. TOWN AND COUNTRY PLANNING ACT 1990

THE STOPPING UP OF HIGHWAYS (CAMBRIA ROAD, MENAI BRIDGE, ANGLESEY) ORDER 2021

The Welsh Ministers have made an Order under section 247 of the Town and Country Planning Act 1990 ("the 1990 Act") to authorise the stopping up of the length of highway described in Schedule 1 to this Notice. The stopping up will be authorised only in order to enable the development to be carried out in accordance with planning permission granted under Part 3 of the 1990 Act by the Welsh Ministers by appeal on 3 June 2021 with reference number APP/L6805/A/21/3270960 described in Schedule 2 to this Notice.

The Stopping Up of Highways (Cambria Road, Menai Bridge, Anglesey) Order 2021 ("the Order") ceases to have effect if planning permission in respect of the development expires or is revoked.

Copies of the Order and the deposited plan may be inspected free of charge at the Isle of Anglesey County Council, Council Offices, Llangefni, Anglesey, LL77 7TW. Alternatively, copies may be obtained free of charge from the address below quoting reference qA1483460, or viewed online on the Welsh Government's website at <https://gov.wales/stopping-orders>.

If a person is aggrieved by the Order, on the grounds that:

- a. it is not within the powers of the 1990 Act; or
- b. a procedural requirement of the 1990 Act has not been complied with;

that person may, within 6 weeks of 3 November 2021 make an application for the purpose to the High Court.
