The County Borough of Bridgend (Electoral Pilot Scheme) Order 2022

EXPLANATORY NOTE

(This note is not part of the Order)

This Order, the County Borough of Bridgend (Electoral Pilot Scheme) Order 2022, makes provision for the implementation of an electoral pilot scheme within the County Borough of Bridgend.

This Order applies to the election of councillors to Bridgend County Borough Council for which the ordinary day of election is 5 May 2022. It also applies to the election of councillors to the community councils within the County Borough of Bridgend, for which the ordinary day of election is 5 May 2022.

Following proposals submitted by Bridgend County Borough Council to the Welsh Ministers, this electoral pilot scheme will provide individuals entitled to vote at those elections, in relevant wards within the County Borough of Bridgend, the opportunity to vote in advance of polling day. Advance voting will take place on Tuesday 3 May 2022 and Wednesday 4 May 2022.

The relevant wards of the County Borough of Bridgend are:

- Brackla East and Coychurch Lower,
- Brackla East Central.
- Brackla West,
- Brackla West Central,
- Cornelly,
- Pyle, Kenfig Hill and Cefn Cribwr, and
- St Bride's Minor and Ynysawdre.

An advance voting station may be situated in each of these relevant wards. Further, the returning officer may also provide for advance voting to take place at Cynffig Comprehensive School for those students registered at that school who are eligible to vote in the wards of Pyle, Kenfig Hill and Cefn Cribwr, and Cornelly.

Schedule 1 modifies relevant primary legislation, namely the Representation of the People Act 1983 (c. 2) and the Representation of the People Act 2000 (c. 2), to give effect to these proposals.

Schedules 2 and 3 modify the Rules which govern the conduct of local government elections to give effect to these proposals:

- Schedule 2 modifies the Local Elections (Principal Areas) (Wales) Rules 2021 (S.I. 2021/1459 (W. 374)) which apply to elections of councillors to the council of a principal area (being a county or county borough);
- Schedule 3 modifies the Local Elections (Communities) (Wales) Rules 2021 (S.I. 2021/1460 (W. 375)) which apply to elections of councillors to a community council within a county or county borough.

Regulatory Impact Assessment

The Welsh Ministers' Code of Practice on the carrying out of Regulatory Impact Assessments was considered in relation to this Order. As a result, it was not considered necessary to carry out a regulatory impact assessment as to the likely costs and benefits of complying with this Order.

The County Borough of Bridgend (Electoral Pilot Scheme) Order 2022

Made

15 March 2022

Coming into force in accordance with article 1

Bridgend County Borough Council has, in accordance with section 10(1) of the Representation of the People Act 2000(1) ("the 2000 Act"), submitted proposals to the Welsh Ministers for a pilot scheme under that section to apply to the local government elections that will take place on 5 May 2022 in relation to the election of councillors to Bridgend County Borough Council, and the election of councillors to the community councils falling within the County Borough of Bridgend.

The Welsh Ministers make the following Order in exercise of the powers conferred on them by section 10(1), (2)(a), (2)(b) and (3)(a) of the 2000 Act(2).

In accordance with section 10(1A) of the 2000 Act, the Welsh Ministers have consulted with the Electoral Commission in relation to the proposals.

Title, coming into force and application

- 1.—(1) The title of this Order is the County Borough of Bridgend (Electoral Pilot Scheme) Order 2022.
 - (2) This Order comes into force on 23 March 2022.
 - (3) This Order applies to—
 - (a) the election of councillors to Bridgend County Borough Council; and

(b) the election of councillors to the community councils within the County Borough of Bridgend,

the ordinary day of election of which is 5 May 2022.

Interpretation

- **2.** In this Order, in any modification to an enactment made by this Order, or in any other enactment which applies in relation to the relevant pilot elections—
 - "1983 Act" ("Deddf 1983") means the Representation of the People Act 1983(1);
 - "Communities Rules" ("Rheolau Cymunedau") means the Local Elections (Communities) (Wales) Rules 2021(2);
 - "Principal Areas Rules" ("Rheolau Prif Ardaloedd") means the Local Elections (Principal Areas) (Wales) Rules 2021(3);
 - "advance voting" ("pleidleisio ymlaen llaw") means voting on an advance voting day, between the hours of—
 - (a) 8:30 a.m. and 4:30 p.m. on the school advance voting day (3 May 2022) at the school advance voting station, and
 - (b) 7 a.m. and 9 p.m. on a general advance voting day (3 and 4 May 2022) at a general advance voting station;
 - "advance voting ballot paper" ("papur pleidleisio ymlaen llaw") means a ballot paper issued to a voter at an advance voting station for the purpose of voting on an advance voting day;
 - "advance voting day" ("diwrnod pleidleisio ymlaen llaw") means—
 - (a) in respect of advance voting at the school advance voting station, 3 May 2022 ("school advance voting day"), and
 - (b) in respect of advance voting at the general advance voting stations, 3 and 4 May 2022 ("general advance voting days");
 - "advance voting station" ("gorsaf pleidleisio ymlaen llaw") means a general advance voting station or the school advance voting station;
 - "close of the poll" ("cau'r bleidlais") means 10 p.m. on 5 May 2022;
 - "date of the poll" or "day of the poll" ("diwrnod y bleidlais" neu "dyddiad y bleidlais") means 5 May 2022;

"general advance voting station" ("gorsaf pleidleisio ymlaen llaw gyffredinol") means a polling station where advance voting is held, excluding the school advance voting station;

"polling station" ("gorsaf bleidleisio") means a polling station on the day of the poll and an advance voting station, except where specific provision is made in relation to an advance voting station differing from that made for a polling station on the day of the poll;

"registered student" ("myfyriwr cofrestredig") means a person who is registered on the admission register for the relevant school, kept in accordance with the Education (Pupil Registration) (Wales) Regulations 2010(1), on or before 14 April 2022;

"relevant pilot election" ("etholiad peilot perthnasol") means—

- (a) the election of councillors to Bridgend County Borough Council, or
- (b) the election of councillors to a community council within the County Borough of Bridgend,

for which the ordinary day of election is 5 May 2022;

"relevant school" ("ysgol berthnasol") means Cynffig Comprehensive School (URN: 401789), East Avenue, Kenfig Hill, Bridgend, CF33 6NP;

"relevant ward" ("ward berthnasol") means any of the following electoral wards within the County Borough of Bridgend—

- (a) Brackla East and Coychurch Lower,
- (b) Brackla East Central,
- (c) Brackla West,
- (d) Brackla West Central,
- (e) Cornelly,
- (f) Pyle, Kenfig Hill and Cefn Cribwr, or
- (g) St Bride's Minor and Ynysawdre;

"school advance voting station" ("gorsaf pleidleisio ymlaen llaw yr ysgol") means a polling station at the relevant school, where advance voting is held only for registered students living within the relevant wards of—

- (a) Pyle, Kenfig Hill and Cefn Cribwr, or
- (b) Cornelly.

Conduct of relevant pilot elections

- **3.**—(1) In relation to a relevant pilot election, the enactments governing the conduct of the elections specified in Schedule 1 to this Order have effect subject to the modifications made by this Order.
- (2) The rules set out in Schedules 1 and 2 to the Principal Areas Rules are to apply to the conduct of the election of councillors to Bridgend County Borough Council the ordinary day of election of which is 5 May 2022, but have effect subject to the modifications made by Schedule 2 to this Order.
- (3) The rules set out in Schedules 1 and 2 to the Communities Rules are to apply to the conduct of the election of councillors to a community council within the County Borough of Bridgend the ordinary day of election of which is 5 May 2022, but have effect subject to the modifications made by Schedule 3 to this Order.
- (4) Where the poll at the election of councillors to Bridgend County Borough Council is taken together with the poll at an election of councillors to a community council within the County Borough of Bridgend, the exercise of those functions specified in regulation 5(2) of the Representation of the People (Combination of Polls) (England and Wales) Regulations 2004(1) (as they apply to local government elections in Wales), will extend, where appropriate, to those functions being exercised on and in relation to an advance voting day as well as the day of the poll.

Advance voting: days, times and place of voting

- **4.**—(1) Any person living within a relevant ward who would be entitled to vote at a relevant pilot election on the day of the poll may vote at an advance voting station on an advance voting day instead of at a polling station on the day of the poll.
- (2) Paragraph (1) applies notwithstanding anything in any enactment.
- (3) Where paragraph (1) applies, the advance voting station will be determined in accordance with paragraph (4).
- (4) A person voting in accordance with paragraph (1)—
 - (a) whose name appears in the electoral register for a relevant ward may vote at the general advance voting station within that relevant ward to which they are allotted by the returning officer, or

- (b) who is a registered student at the relevant school and whose name appears in the electoral register for either of the following relevant wards:
 - (i) Pyle, Kenfig Hill and Cefn Cribwr, or
 - (ii) Cornelly,

may vote at the school advance voting station to which they are allotted by the returning officer.

(5) A person who is eligible to vote at both a general advance voting station, under paragraph (4)(a), and the school advance voting station, under paragraph (4)(b),

will be permitted to vote at either advance voting station but will only be entitled to vote once.

SCHEDULE 1 Article 3(1)

Modifications to Enactments

The 1983 Act

- 1. The 1983 Act is modified as follows—
 - (a) in section 2(1)(1) (local government electors), after "electoral area" insert ", on an advance voting day or the day of the poll,";
 - (b) in section 49(2) (effect of registers)—
 - (i) for subsection (4) substitute—
 - "(4) Subject to subsection (4B), any entry in the register of parliamentary or local government electors, if it gives a date as that on which the person named will attain voting age, will for any purpose of this Part relating to the person as elector, be conclusive that until the date given in the entry the person is not of voting age nor entitled to be treated as an elector.",
 - (ii) after subsection (4A) insert—
 - "(4B) A person is entitled to be treated as an elector for the purposes of voting at an advance voting station on an advance voting day where the date relating to the person in the register is the 5 May 2022 or any earlier date.";
 - (c) in section 66(3) (requirement of secrecy), after subsection (8) insert—
 - "(9) Nothing in this section prevents the returning officer from carrying out an enquiry, either before or after the close of the poll, concerning whether an elector or the elector's proxy has voted, and the manner and location in which they did so.";
 - (d) in section 202 (general provisions as to interpretation), in the appropriate place insert—
 - ""advance voting day" means 3 and 4 May 2022;

"advance voting station" means a polling station where advance voting is held;".

The 2000 Act

2. After section 10 of the 2000 Act insert—

"Duty to co-operate with the Electoral Commission

- **10A.**—(1) The returning officer for a local government election to which an order under section 10 applies must ensure that the Electoral Commission, and any person authorised by the Commission, is afforded access to any ballot paper, document, equipment, computer software, computer hardware, data stored electronically or place that is to be, is being, or has been used for the purpose of the election.
- (2) Sub-section (1) will apply only to the extent that the Electoral Commission reasonably requires access to the ballot paper, document, equipment, computer software, computer hardware, data stored electronically or place, for the purpose of enabling the Commission to assess the election in question and prepare its report in accordance with section 10(6).
- (3) Sub-section (1) will not require the returning officer to give access, without an order of the court, to any ballot paper, document, equipment, computer software, computer hardware, data stored electronically which, by reason of the requirement in any enactment, is contained within a sealed packet."

1. The Principal Areas Rules are modified in accordance with paragraphs 2 to 48.

- **3.** In rule 27 (notice of poll), for paragraph (1)(a) substitute—
 - "(a) the days and hours fixed for the advance voting days and the day of the poll,".
- **4.** For rule 29 (provision of polling stations), substitute—

"Provision of polling stations and advance voting stations

- **29.**—(1) The returning officer must—
 - (a) provide a sufficient number of polling stations on the day of the poll, and
 - (b) allot the electors to the polling stations.
- (2) One or more polling stations may be provided in the same room.
 - (3) The returning officer may also provide—
 - (a) general advance voting stations for polling on a general advance voting day (3 or 4 May 2022) within the relevant wards, and
 - (b) the school advance voting station for polling on the school advance voting day (3 May 2022).
- (4) Where the returning officer provides for advance voting in accordance with paragraph (3)(a), the returning officer may allot electors living within the relevant wards to a general advance voting station.
- (5) The general advance voting station to which an elector living within a relevant ward is allotted in accordance with paragraph (4) must be the same as the polling station to which that

elector is allotted by the returning officer under rule 29(1)(b) for the day of the poll.

- (6) Where the returning officer provides for advance voting in accordance with paragraph (3)(b) for an elector who is a registered student living within the relevant wards of Pyle, Kenfig Hill and Cefn Cribwr or Cornelly, the returning officer may—
 - (a) allot that elector to a general advance voting station in accordance with paragraph (4), and
 - (b) allot that elector to the school advance voting station.
- (7) The returning officer must provide each polling station and advance voting station with such number of compartments as may be necessary in which voters can mark their votes screened from observation."
- **5.** In rule 31(4) (issue of official poll cards), after sub-paragraph (d) insert—
 - "(da) the dates and hours of advance voting and the situation of the elector's advance voting station,".
 - **6.** In rule 32 (equipment of polling stations)—
 - (a) after paragraph (3) insert—
 - "(3A) In relation to an advance voting station on an advance voting day, in paragraph (3), "the relevant register of electors" means—
 - (a) in respect of a general advance voting station—
 - (i) the register of electors for the relevant ward or such part of it as contains the entries relating to the electors allotted to the general advance voting station, and
 - (ii) within the relevant wards of Pyle, Kenfig Hill and Cefn Cribwr and Cornelly, the register of electors who are registered students and who have been allotted to the general advance voting station;
 - (b) in respect of the school advance voting station, a register of electors who are registered students living within the relevant ward of Pyle, Kenfig Hill and Cefn Cribwr and a separate register of electors who are registered students living within the relevant ward of Cornelly.";
 - (b) in paragraph (4), for "In paragraph (3)" substitute "In relation to a polling station on the day of the poll, in paragraph (3)";

- (c) after paragraph (4) insert—
 - "(4A) The copies of the relevant register of electors, or the relevant part of the register of electors, and corresponding number list provided to a polling station on the day of the poll must take account of any votes cast at an advance voting station on an advance voting day."
- 7. In rule 33 (appointment of polling and counting agents)—
 - (a) in paragraph (1)(b), after "votes" insert "and the early verification of advance voting ballot papers";
 - (b) in paragraph (5)(b), after "count" insert "or the early verification of advance voting ballot papers (whichever is applicable)".
- **8.** In rule 38 (keeping of order in station), for paragraph (4) substitute—
 - "(4) Where a person is removed from an advance voting station on an advance voting day, the person must not, without the presiding officer's permission, re-enter the advance voting station on that day or on any subsequent advance voting day, or enter a polling station on the day of the poll.
 - (4A) Where a person is removed from the polling station on the day of the poll, the person must not, without the presiding officer's permission, re-enter the polling station on that day."
- **9.** In rule 39(1) (sealing of ballot boxes), for "the poll begins" substitute "polling begins on each advance voting day and the day of the poll".
 - **10.** For rule 42(7) (voting procedure), substitute—
 - "(7) If a voter is
 - (a) in the school advance voting station, or in a queue outside the school advance voting station at 4:30 p.m. on the school advance voting day (3 May 2022),
 - (b) in a general advance voting station, or in a queue outside a general advance voting station at 9 p.m. on a general advance voting day (3 or 4 May 2022), or
 - (c) in a polling station, or in a queue outside a polling station at the close of the poll on the day of the poll,

and has not yet been able to cast their vote, the presiding officer must permit the voter to cast their vote as soon as practicable."

- **11.** In rule 49 (correction of errors on day of poll), for "The presiding officer" substitute "On an advance voting day and the day of the poll, the presiding officer".
- **12.** For rule 50 (adjournment of poll in case of riot), substitute—

"Adjournment of poll in case of riot

- **50.**—(1) This rule applies where proceedings at any polling station are interrupted or obstructed by riot or open violence.
- (2) Where the interruption occurs on an advance voting day, the presiding officer must—
 - (a) where there is a further advance voting day scheduled, adjourn the proceedings to that day, or
 - (b) where there is no further advance voting day scheduled, adjourn the proceedings to the day of the poll,

and immediately inform the returning officer.

- (3) Where the interruption occurs on the day of the poll, the presiding officer must—
 - (a) adjourn the proceedings until the following day, and
 - (b) immediately inform the returning officer.
- (4) Where polling is adjourned to a further advance voting day, the hours of polling will be as prescribed for that advance voting day, and polling will take place at the advance voting station to which electors are allotted by the returning officer.
 - (5) Where polling is adjourned—
 - (a) to the day of the poll, or
 - (b) on the day of the poll to the following day,

the hours of polling will be as prescribed for the day of the poll, and polling will take place at the polling stations to which electors are allotted by the returning officer for polling on the day of the poll.

- (6) References in these rules to the close of the poll are to be read as references to the end of the hours of polling on the day of the poll on the day to which it is adjourned."
- **13.** After rule 50 (adjournment of poll in case of riot), insert—

"Procedure on close of polling on a general advance voting day at a general advance voting station

- **50A.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on a general advance voting day.
- (2) At the end of the each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the general advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) At the end of each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
 - (d) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);
 - (iii) the list of voters with disabilities assisted by companions (see rule 45):
 - (iv) the tendered votes list (see rule 47);
 - (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the returning officer or cause them to be delivered

in accordance with arrangements approved by the returning officer.

- (5) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (6) At the end of the first general advance voting day the presiding officer must take all reasonable precautions to ensure the security of—
 - (a) the marked copies of the registration records and the list of proxies;
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)); and
 - (c) any other documents which are not delivered to the returning officer pursuant to paragraph (4),

ahead of the second general advance voting day.

- (7) At the end of the second general advance voting day the presiding officer must deliver to the returning officer, or cause to be delivered in accordance with arrangements approved by the returning officer—
 - (a) the marked copies of the registration records and the list of proxies; and
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list").
- (8) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the returning officer must take proper precautions for the security of the ballot papers and other documents.

(9) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules.

Procedure on close of polling on the school advance voting day at the school advance voting station

- **50B.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on the school advance voting day.
- (2) At the end of the school advance voting day, in the presence of the polling agents at the school advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the school advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) The presiding officer must, at the end of the school advance voting day, place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) the school advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list");
 - (d) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
 - (e) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44):
 - (iii) the list of voters with disabilities assisted by companions (see rule 45);

- (iv) the tendered votes list (see rule 47);
- (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must do anything required by paragraph (3)(a), (b), (d) or (e) in the school advance voting station, in the presence of any polling agents who are there.
- (5) The presiding officer may do anything required by paragraph (3)(c)—
 - (a) in the school advance voting station, in the presence of any polling agents who are there, or
 - (b) if the presiding officer has informed the polling agents and given them an opportunity to attend, at any other place that the presiding officer considers appropriate, in the presence of any polling agents who are there.
- (6) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the returning officer or cause them to be delivered in accordance with arrangements approved by the returning officer.
- (7) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused:
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (8) The presiding officer must also deliver the marked copies of the registration records and the list of proxies to the returning officer or cause them to be delivered in accordance with arrangements approved by the returning officer.
- (9) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the returning officer must take proper precautions for the security of the ballot papers and other documents.

- (10) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules."
- **14.** After rule 52 (arrangements for the counting of votes), insert—

"Early verification of advance voting ballot papers

- **52A.**—(1) A returning officer may open the ballot boxes containing advance voting ballot papers after the close of polling on the final advance voting day but before the close of the poll, for the purpose of verifying those ballot papers only.
- (2) Where advance voting ballot papers are not verified early in accordance with this rule, they will be verified in accordance with rule 54.
- (3) Any votes given on an advance voting ballot paper verified before the close of poll in accordance with this rule will be counted following the close of poll in accordance with rules 54(6) to 59.
- (4) The counting agents and the election agents are entitled to be present when a ballot box containing advance voting ballot papers is opened by the returning officer before the close of the poll, and the returning officer must give the counting agents and election agents a notice stating the time and place at which the returning officer will verify the advance voting ballot papers.
- (5) The returning officer must, in the presence of the counting agents—
 - (a) open each ballot box used at the school advance voting station, take out the advance voting ballot papers, count them and record the number of ballot papers, and
 - (b) open each ballot box used at the general advance voting station, take out the advance voting ballot papers, count them and record the number of ballot papers.
- (6) The returning officer must not count any tendered ballot papers.
- (7) The returning officer must, in the presence of the election agents, verify each ballot paper account by comparing it with—

- (a) the number of ballot papers recorded on the advance voting days at each advance voting station,
- (b) the unused and spoilt ballot papers at each advance voting station in the returning officer's possession following the advance voting days, and
- (c) the tendered votes list marked at each advance voting station from the advance voting days,

(opening and resealing the packets containing the unused and spoilt ballot papers and tendered votes list).

- (8) The returning officer must prepare a statement as to the result of the verification and give a copy of the statement to any election agent who requests it.
- (9) While counting and recording the number of advance voting ballot papers for the purposes of verification, the returning officer must keep the ballot papers with their faces downwards and take proper precautions to prevent any person from seeing the votes made on the advance voting ballot papers.
- (10) Following the completion of the verification process the advance voting ballot papers must be returned to one ballot box (or more than one ballot box if the ballet papers do not fit into one ballot box) for each advance voting station and each ballot box must be sealed (with the key if any attached), using the returning officer's seal and the seals of any election agents who wish to affix their seal.
- (11) Following the sealing of the ballot boxes in accordance with paragraph (10), the returning officer must take proper precautions for the security of the ballot papers and other documents, until the ballot boxes are reopened in accordance with rule 54 for the purposes of counting the votes given.
- (12) The returning officer must make arrangements to ensure that every person attending at the verification of advance voting ballot papers has been given a notice setting out the provisions of section 66(2) and (6) of the 1983 Act (notification of requirement of secrecy)."

15. In rule 54 (the count: steps)—

(a) after paragraph (5) insert—

"(5A) Paragraphs (2) to (5) do not apply in relation to advance voting ballot papers which have previously been verified in accordance with rule 52A.";

- (b) before paragraph (7)(a) insert—
 - "(za) handed in at a general advance voting station in the electoral ward before the close of polling on any day that the general advance voting station is open,
 - (zb) for registered students only, handed in at the school advance voting station before the close of polling on the day that the school advance voting station is open,";
- (c) after paragraph (8) insert—

"(8A) Where—

- (a) at 4:30 p.m. on the school advance voting day (3 May 2022), a registered student is in the school advance voting station, or in a queue outside the school advance voting station, or
- (b) at 9 p.m. on a general advance voting day (3 or 4 May 2022), a person is in a general advance voting station, or in a queue outside a general advance voting station,

for the purpose of handing in a postal ballot paper and postal voting statement, the person must be permitted to hand the ballot paper and statement in at the advance voting station, and where handed in, they are to be treated as having been properly returned for the purposes of this rule.":

- (d) after paragraph (10)(a) insert—
 - "(aa) in the case of advance voting ballot papers verified in accordance with rule 52A, they have been mixed with the ballot papers from at least one other ballot box, and".

elector is allotted by the returning officer under rule 29(1)(b) for the day of the poll.

- (6) Where the returning officer provides for advance voting in accordance with paragraph (3)(b) for an elector who is a registered student living within the relevant wards of Pyle, Kenfig Hill and Cefn Cribwr or Cornelly, the returning officer may—
 - (a) allot that elector to a general advance voting station in accordance with paragraph (4), and
 - (b) allot that elector to the school advance voting station.
- (7) The returning officer must provide each polling station and advance voting station with such number of compartments as may be necessary in which voters can mark their votes screened from observation.

 - (b) where there is no further advance voting day scheduled, adjourn the proceedings to the day of the poll,

and immediately inform the returning officer.

- (3) Where the interruption occurs on the day of the poll, the presiding officer must—
 - (a) adjourn the proceedings until the following day, and
 - (b) immediately inform the returning officer.
- (4) Where polling is adjourned to a further advance voting day, the hours of polling will be as prescribed for that advance voting day, and polling will take place at the advance voting station to which electors are allotted by the returning officer.
 - (5) Where polling is adjourned—
 - (a) to the day of the poll, or
 - (b) on the day of the poll to the following day,

the hours of polling will be as prescribed for the day of the poll, and polling will take place at the polling stations to which electors are allotted by the returning officer for polling on the day of the poll.

- (6) References in these rules to the close of the poll are to be read as references to the end of the hours of polling on the day of the poll on the day to which it is adjourned."

- **50A.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on a general advance voting day.
- (2) At the end of the each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the general advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) At the end of each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
 - (d) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);
 - (iii) the list of voters with disabilities assisted by companions (see rule 45);

- (iv) the tendered votes list (see rule 47);
- (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the coordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.
- (5) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (6) At the end of the first general advance voting day the presiding officer must take all reasonable precautions to ensure the security of—
 - (a) the marked copies of the registration records and the list of proxies;
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)); and
 - (c) any other documents which are not delivered to the co-ordinating returning officer pursuant to paragraph (4),

ahead of the second general advance voting day.

- (7) At the end of the second general advance voting day the presiding officer must deliver to the co-ordinating returning officer, or cause to be delivered in accordance with arrangements approved by that returning officer—
 - (a) the marked copies of the registration records and the list of proxies; and
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list").

- (8) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the co-ordinating returning officer must take proper precautions for the security of the ballot papers and other documents.

(9) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules.

Procedure on close of polling on the school advance voting day at the school advance voting station

- **50B.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on the school advance voting day.
- (2) At the end of the school advance voting day, in the presence of the polling agents at the school advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the school advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) The presiding officer must, at the end of the school advance voting day, place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) the school advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list");
 - (d) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
 - (e) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a

- statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
- (ii) the declarations made by the companions of voters with disabilities (see rule 44);
- (iii) the list of voters with disabilities assisted by companions (see rule 45);
- (iv) the tendered votes list (see rule 47);
- (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must do anything required by paragraph (3)(a), (b), (d) or (e) in the school advance voting station, in the presence of any polling agents who are there.
- (5) The presiding officer may do anything required by paragraph (3)(c)—
 - (a) in the school advance voting station, in the presence of any polling agents who are there, or
 - (b) if the presiding officer has informed the polling agents and given them an opportunity to attend, at any other place that the presiding officer considers appropriate, in the presence of any polling agents who are there.
- (6) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the coordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.
- (7) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (8) The presiding officer must also deliver the marked copies of the registration records and

the list of proxies to the co-ordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.

- (9) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the co-ordinating returning officer must take proper precautions for the security of the ballot papers and other documents.

- (10) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules."

 - (a) the number of ballot papers recorded on the advance voting days at each advance voting station,

(c) the tendered votes list marked at each advance voting station from the advance voting days,

(opening and resealing the packets containing the unused and spoilt ballot papers and tendered votes list).

- (8) While counting and recording the number of advance voting ballot papers for the purposes of verification, the returning officer must keep the ballot papers with their faces downwards and take proper precautions to prevent any person from seeing the votes made on the advance voting ballot papers.
- (9) The returning officer must prepare a statement as to the result of the verification and give a copy of the statement to any principal election agent, and to any other election agent, who requests it.
 - (10) The returning officer must also—
 - (a) count the postal ballot papers that have been properly returned (as to which see rule 58), and
 - (b) record separately the number counted at the advance voting days at the principal area election and any other relevant election.
 - (11) The returning officer must then—
 - (a) separate the advance voting ballot papers relating to the principal area election from the advance voting ballot papers relating to any other relevant election,
 - (b) make up into packets the advance voting ballot papers for any other relevant election, and
 - (c) seal up the packets in separate containers endorsing on each a description of the area to which the advance voting ballot papers relate.
- (12) The returning officer must then deliver or cause to be delivered to the returning officer for each relevant election—
 - (a) the containers of advance voting ballot papers relating to the election, together with a list of the containers and their contents,
 - (b) the advance voting ballot paper accounts relating to the election, together with a copy of the statements as to the result of the verification, and
 - (c) the packets of unused and spoilt advance voting ballot papers and tendered advance voting ballot papers.

- (3) At the end of each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
 - (d) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);

- (iii) the list of voters with disabilities assisted by companions (see rule 45);
- (iv) the tendered votes list (see rule 47);
- (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the returning officer or cause them to be delivered in accordance with arrangements approved by the returning officer.
- (5) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (6) At the end of the first general advance voting day the presiding officer must take all reasonable precautions to ensure the security of—
 - (a) the marked copies of the registration records and the list of proxies;
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)); and
 - (c) any other documents which are not delivered to the returning officer pursuant to paragraph (4),

ahead of the second general advance voting day.

- (7) At the end of the second general advance voting day the presiding officer must deliver to the returning officer, or cause to be delivered in accordance with arrangements approved by the returning officer—
 - (a) the marked copies of the registration records and the list of proxies; and
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the

following provisions of these rules as "the completed corresponding number list").

- (8) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the returning officer must take proper precautions for the security of the ballot papers and other documents.

(9) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules.

Procedure on close of polling on the school advance voting day at the school advance voting station

- **50B.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on the school advance voting day.
- (2) At the end of the school advance voting day, in the presence of the polling agents at the school advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the school advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) The presiding officer must, at the end of the school advance voting day, place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;
 - (c) the school advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list");
 - (d) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);

- (e) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);
 - (iii) the list of voters with disabilities assisted by companions (see rule 45);
 - (iv) the tendered votes list (see rule 47);
 - (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must do anything required by paragraph (3)(a), (b), (d) or (e) in the school advance voting station, in the presence of any polling agents who are there.
- (5) The presiding officer may do anything required by paragraph (3)(c)—
 - (a) in the school advance voting station, in the presence of any polling agents who are there, or
 - (b) if the presiding officer has informed the polling agents and given them an opportunity to attend, at any other place that the presiding officer considers appropriate, in the presence of any polling agents who are there.
- (6) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the returning officer or cause them to be delivered in accordance with arrangements approved by the returning officer.
- (7) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;

- (iv) the number of tendered ballot papers.
- (8) The presiding officer must also deliver the marked copies of the registration records and the list of proxies to the returning officer or cause them to be delivered in accordance with arrangements approved by the returning officer.
- (9) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the returning officer must take proper precautions for the security of the ballot papers and other documents.

- (10) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules."
- **14.** After rule 52 (arrangements for the counting of votes), insert—

"Early verification of advance voting ballot papers

- **52A.**—(1) A returning officer may open the ballot boxes containing advance voting ballot papers after the close of polling on the final advance voting day but before the close of the poll, for the purpose of verifying those ballot papers only.
- (2) Where advance voting ballot papers are not verified early in accordance with this rule, they will be verified in accordance with rule 54.
- (3) Any votes given on an advance voting ballot paper verified before the close of poll in accordance with this rule will be counted following the close of poll in accordance with rules 54(7) to 59.
- (4) The counting agents and the election agents (if appointed) are entitled to be present when a ballot box containing advance voting ballot papers is opened by the returning officer before the close of the poll, and the returning officer must give the counting agents and election agents a notice stating the time and place at which the returning officer will verify the advance voting ballot papers.
- (5) The returning officer must, in the presence of the counting agents—
 - (a) open each ballot box used at the school advance voting station, take out the

- advance voting ballot papers, count them and record the number of ballot papers, and
- (b) open each ballot box used at the general advance voting station, take out the advance voting ballot papers, count them and record the number of ballot papers.
- (6) The returning officer must not count any tendered ballot papers.
- (7) The returning officer must, in the presence of the election agents (if appointed), verify each ballot paper account by comparing it with—
 - (a) the number of ballot papers recorded on the advance voting days at each advance voting station,
 - (b) the unused and spoilt ballot papers at each advance voting station in the returning officer's possession following the advance voting days, and
 - (c) the tendered votes list marked at each advance voting station from the advance voting days,

(opening and resealing the packets containing the unused and spoilt ballot papers and tendered votes list).

- (8) The returning officer must prepare a statement as to the result of the verification and give a copy of the statement to any election agent who requests it.
- (9) Where a candidate has not appointed an election agent—
 - (a) the verification of the ballot paper account must be done in the presence of the candidate's counting agents instead, and
 - (b) a copy of the statement must be given to any of the candidate's counting agents who requests it.
- (10) While counting and recording the number of advance voting ballot papers for the purposes of verification, the returning officer must keep the ballot papers with their faces downwards and take proper precautions to prevent any person from seeing the votes made on the advance voting ballot papers.
- (11) Following the completion of the verification process the advance voting ballot papers must be returned to one ballot box (or more than one ballot box if the ballet papers do not fit into one ballot box) for each advance voting station and each ballot box must be sealed (with the key if any attached), using the

returning officer's seal and the seals of any election agents (if appointed) who wish to affix their seal.

- (12) Following the sealing of the ballot boxes in accordance with paragraph (11), the returning officer must take proper precautions for the security of the ballot papers and other documents, until the ballot boxes are reopened in accordance with rule 54 for the purposes of counting the votes given.
- (13) The returning officer must make arrangements to ensure that every person attending at the verification of advance voting ballot papers has been given a notice setting out the provisions of section 66(2) and (6) of the 1983 Act (notification of requirement of secrecy)."

15. In rule 54 (the count: steps)—

- (a) after paragraph (5) insert—
 - "(5A) Paragraphs (2) to (5) do not apply in relation to advance voting ballot papers which have previously been verified in accordance with rule 52A.":
- (b) before paragraph (8)(a) insert—

 - (zb) for registered students only, handed in at the school advance voting station before the close of polling on the day that the school advance voting station is open,";

"(9A) Where—

- (a) at 4:30 p.m. on the school advance voting day (3 May 2022), a registered student is in the school advance voting station, or in a queue outside the school advance voting station, or
- (b) at 9 p.m. on a general advance voting day (3 or 4 May 2022), a person is in a general advance voting station, or in a queue outside a general advance voting station,

for the purpose of handing in a postal ballot paper and postal voting statement, the person must be permitted to hand the ballot paper and statement in at the advance voting station, and where handed in, they are to be treated as having been properly returned for the purposes of this rule.";

- (d) after paragraph (11)(a) insert—
 - "(aa) in the case of advance voting ballot papers verified in accordance with rule 52A, they have been mixed with the ballot papers from at least one other ballot box, and".

 - (d) handed in on a general advance voting day (3 or 4 May 2022) at a general advance voting station in the electoral area before 9 p.m.; or

- (b) immediately inform the returning officer.

 - (5) Where polling is adjourned—
 - (a) to the day of the poll, or

the hours of polling will be as prescribed for the day of the poll, and polling will take place at the polling stations to which electors are allotted by the returning officer for polling on the day of the poll.

- (6) References in these rules to the close of the poll are to be read as references to the end of the hours of polling on the day of the poll on the day to which it is adjourned."
- **34.** After rule 50 (adjournment of poll in case of riot), insert—

"Procedure on close of polling on a general advance voting day at a general advance voting station

- **50A.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on a general advance voting day.
- (2) At the end of the each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the general advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) At the end of each general advance voting day, in the presence of the polling agents at the general advance voting station, the presiding officer must place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—
 - (a) the unused and spoilt ballot papers (together);
 - (b) the tendered ballot papers;

- (c) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
- (d) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);
 - (iii) the list of voters with disabilities assisted by companions (see rule 45):
 - (iv) the tendered votes list (see rule 47):
 - (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the coordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.
- (5) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused;
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (6) At the end of the first general advance voting day the presiding officer must take all reasonable precautions to ensure the security of—
 - (a) the marked copies of the registration records and the list of proxies;
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)); and

(c) any other documents which are not delivered to the co-ordinating returning officer pursuant to paragraph (4),

ahead of the second general advance voting day.

- (7) At the end of the second general advance voting day the presiding officer must deliver to the co-ordinating returning officer, or cause to be delivered in accordance with arrangements approved by that returning officer—
 - (a) the marked copies of the registration records and the list of proxies; and
 - (b) the general advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list").
- (8) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the co-ordinating returning officer must take proper precautions for the security of the ballot papers and other documents.

(9) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules.

Procedure on close of polling on the school advance voting day at the school advance voting station

- **50B.**—(1) This rule sets out the steps that must be taken by the presiding officer as soon as practicable after polling has ended on the school advance voting day.
- (2) At the end of the school advance voting day, in the presence of the polling agents at the school advance voting station, the presiding officer must seal each ballot box (with the key if any attached) in use at the school advance voting station so as to prevent the introduction of additional ballot papers, using the presiding officer's seal and the seals of any polling agents who wish to affix their seal.
- (3) The presiding officer must, at the end of the school advance voting day, place each of the following in separate packets, sealed using the presiding officer's seal and the seals of any polling agents who wish to affix their seal—

- (a) the unused and spoilt ballot papers (together);
- (b) the tendered ballot papers;
- (c) the school advance voting station's corresponding number list, as marked (see rule 42(2)(c)) (referred to in the following provisions of these rules as "the completed corresponding number list");
- (d) any certificates surrendered under rule 37(4) or (5) (surrender of certificates issued to constables or staff of returning officers);
- (e) the following lists and declarations (together)—
 - (i) the list of votes marked by the presiding officer, together with a statement of the number of voters whose votes are marked under the heads "disability" and "unable to read" (see rule 43);
 - (ii) the declarations made by the companions of voters with disabilities (see rule 44);
 - (iii) the list of voters with disabilities assisted by companions (see rule 45);
 - (iv) the tendered votes list (see rule 47);
 - (v) the list maintained under rule 49 (correction of errors on an advance voting day).
- (4) The presiding officer must do anything required by paragraph (3)(a), (b), (d) or (e) in the school advance voting station, in the presence of any polling agents who are there.
- (5) The presiding officer may do anything required by paragraph (3)(c)—
 - (a) in the school advance voting station, in the presence of any polling agents who are there, or
 - (b) if the presiding officer has informed the polling agents and given them an opportunity to attend, at any other place that the presiding officer considers appropriate, in the presence of any polling agents who are there.
- (6) The presiding officer must deliver the sealed ballot boxes under paragraph (2) and the sealed packets under paragraph (3) to the coordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.

- (7) The packets must be accompanied by a statement ("a ballot paper account") prepared by the presiding officer showing—
 - (a) the number of ballot papers given to the presiding officer;
 - (b) how the ballot papers are accounted for under the following headings—
 - (i) the number of ballot papers issued and not otherwise accounted for;
 - (ii) the number of ballot papers unused:
 - (iii) the number of spoilt ballot papers;
 - (iv) the number of tendered ballot papers.
- (8) The presiding officer must also deliver the marked copies of the registration records and the list of proxies to the co-ordinating returning officer or cause them to be delivered in accordance with arrangements approved by that returning officer.
- (9) During any time between receiving the ballot papers and other documents, and—
 - (a) the early verification of advance voting ballot papers in accordance with rule 52A, or
 - (b) the counting of the votes,

the co-ordinating returning officer must take proper precautions for the security of the ballot papers and other documents.

- (10) In this rule, "the marked copies of the registration records" means the copies of the registration records (as defined by rule 40(7)), as marked in accordance with these rules."
- **35.** In rule 52(2) (overview of rules and interpretation), after sub-paragraph (b) insert—
 - "(ba) rule 54A (early verification and separation of advance voting ballot papers etc. where the returning officer is the co-ordinating returning officer),".
- **36.** In rule 53 (attendance at proceedings under this Part)—
 - (a) in paragraph (1), for "rules 55(2) to (10)" substitute "rules 54A(3) to (13), 55(2) to (10), 55(10A)";
 - (b) in paragraph (2), for "rule 55(2) to (10)" substitute "rules 54A(3) to (13), 55(2) to (10) and 55(10A)";
 - (c) in paragraph (3), for "rules 55(2) to (10)" substitute "rules 54A(3) to (13), 55(2) to (10), 55(10A)";

- (d) in paragraph (5)(a), for "rule 55(2) to (10)" substitute "rules 54A(3) to (13), 55(2) to (10) and 55(10A)".
- **37.** In rule 54 (preliminary and general duties where returning officer is co-ordinating returning officer), after paragraph (1) insert—
 - "(1A) The returning officer may verify and separate advance voting ballot papers in accordance with rule 54A."
- **38.** After rule 54 (preliminary and general duties where returning officer is co-ordinating returning officer), insert—

"Early verification and separation of advance voting ballot papers etc. where the returning officer is the co-ordinating returning officer

- **54A.**—(1) A returning officer who is the coordinating returning officer may open the ballot boxes containing advance voting ballot papers for each election after the close of polling on the final advance voting day but before the close of the poll, for the purpose of verifying those ballot papers only.
- (2) Where advance voting ballot papers are not verified early in accordance with this rule, they will be verified in accordance with rule 55.
- (3) Any votes given on an advance voting ballot paper verified before the close of poll in accordance with this rule will be counted following the close of poll in accordance with rules 59 to 61.
- (4) The returning officer must, in the presence of the community counting agents and the other counting agents—
 - (a) open each ballot box used at the school advance voting station, take out the advance voting ballot papers, count them and record separately the number of ballot papers used in each relevant election, and
 - (b) open each ballot box used at the general advance voting station, take out the advance voting ballot papers, count them and record separately the number of ballot papers used in each relevant election.
- (5) The returning officer must not count any tendered ballot papers.
- (6) Where separate ballot boxes were used on an advance voting day, no vote for a candidate in the community election is to be treated as

invalid because it was placed in the ballot box intended for use at a relevant election.

- (7) The returning officer must, in the presence of the community election agents (if appointed) and the other election agents, verify each ballot paper account by comparing it with—
 - (a) the number of ballot papers recorded on the advance voting days at each advance voting station,
 - (b) the unused and spoilt ballot papers at each advance voting station in the returning officer's possession following the advance voting days, and
 - (c) the tendered votes list marked at each advance voting station from the advance voting days,

(opening and resealing the packets containing the unused and spoilt ballot papers and tendered votes list).

- (8) While counting and recording the number of advance voting ballot papers for the purposes of verification, the returning officer must keep the ballot papers with their faces downwards and take proper precautions to prevent any person from seeing the votes made on the advance voting ballot papers.
- (9) The returning officer must prepare a statement as to the result of the verification and give a copy of the statement to any community election agent (if appointed), and to any other election agent, who requests it.
- (10) Where a candidate at the community election has not appointed an election agent—
 - (a) the verification of the ballot paper account must be done in the presence of the candidate's counting agents instead, and
 - (b) on request, a copy of the statement must be given to the candidate.
 - (11) The returning officer must also—
 - (a) count the postal ballot papers that have been properly returned (as to which see rule 58), and
 - (b) record separately the number counted at the advance voting days at the community election and any other relevant election.
 - (12) The returning officer must then—
 - (a) separate the advance voting ballot papers relating to the community election from the advance voting ballot

- papers relating to any other relevant election.
- (b) make up into packets the advance voting ballot papers for any other relevant election, and
- (c) seal up the packets in separate containers endorsing on each a description of the area to which the advance voting ballot papers relate.
- (13) The returning officer must then deliver or cause to be delivered to the returning officer for each relevant election—
 - (a) the containers of advance voting ballot papers relating to the election, together with a list of the containers and their contents.
 - (b) the advance voting ballot paper accounts relating to the election, together with a copy of the statements as to the result of the verification, and
 - (c) the packets of unused and spoilt advance voting ballot papers and tendered advance voting ballot papers.
- (14) Following the completion of the verification process the advance voting ballot papers in relation to the community election must be returned to one ballot box (or more than one ballot box if the ballet papers do not fit into one ballot box) for each advance voting station and each ballot box must be sealed (with the key if any attached), using the returning officer's seal and the seals of any community election agents (if appointed) who wish to affix their seal.
- (15) Following the sealing of the ballot boxes in accordance with paragraph (14) the returning officer must take proper precautions for the security of the advance voting ballot papers and other documents, until the advance voting ballot papers are counted in accordance with rules 59 to 61."
- **39.** In rule 55 (separation of ballot papers etc. where returning officer is co-ordinating returning officer)—
