

**GORCHYMYN CEFNFFORDD YR A470  
(NORTH STREET, RHAADR GWY, POWYS)  
(GWAHARDD AROS) 2022**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 1(1), 2(1), 2(2), 4(2) a 124(1)(d) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a pharagraff 27(1) o Atodlen 9 iddi, sy'n dod i rym ar 26 Mawrth 2022.

Effaith y Gorchymyn yw gwahardd aros ar unrhyw adeg ar ochr orllewinol y darn o gefnffordd yr A470 sy'n ymestyn i gyfeiriad y gogledd-orllewin o bwynt 28 o fetrau i'r gogledd-orllewin o linell cwrw ogleddol y B4518 Heol y Bont am bellter o 55 o fetrau yn North Street, Rhaeadr Gwy, Powys. Bydd esemptiadau, gan gynnwys un ar gyfer deiliaid bathodyn person anabl.

- b. na chydymffurfiwyd ag unrhyw un neu ragor o'r gofynion perthnasol,

**THE A470 TRUNK ROAD (NORTH STREET,  
RHAYADER, POWYS) (PROHIBITION OF  
WAITING) ORDER 2022**

The Welsh Ministers have made an Order in exercise of their powers under sections 1(1), 2(1), 2(2), 4(2) and 124(1)(d) of, and paragraph 27(1) of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on 26 March 2022.

The effect of the Order is to prohibit waiting at any time on the western side of the length of the A470 trunk road that extends in a north-westerly direction from a point 28 metres north-west of the northern kerb line of the B4518 Bridge Street for a distance of 55 metres at North Street, Rhayader, Powys. There will be exemptions, including one for disabled person's badge holders.

During a period of 6 weeks from 24 March 2022, a copy of this Notice, the Order, plan and the Order being partly revoked can be viewed on the Welsh Government's website at <https://gov.wales/road-orders> or may be obtained free of charge by emailing [TransportOrdersBranch@gov.wales](mailto:TransportOrdersBranch@gov.wales) or writing to Orders Branch, Transport, Welsh Government, Cathays Park, Cardiff CF10 3NQ, quoting reference number qA1412662.

If any person desires to question the validity of the Order, or of any provisions contained therein on the grounds:

- a. that it is not within the relevant powers of the Road Traffic Regulation Act 1984; or
- b. that any of the relevant requirements have not been complied with,

that person may, within 6 weeks of 24 March 2022, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
