Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A470, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Rhaeadr Gwy, Powys) (Gwahardd Cerbydau, Beicwyr a Marchogwyr Dros Dro) 2022 a daw'r Gorchymyn hwn i rym ar 5 Mawrth 2022.

1. The title of this Order is the A470 Trunk Road (Rhayader, Powys) (Temporary Prohibition of Vehicles, Cyclists & Equestrians) Order 2022 and this Order comes into force on 5 March 2022.

2. In this Order—

ystyr "cerbyd esempt" ("*exempted vehicle*") yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 07:00 o’r gloch ar 5 Mawrth 2022 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw’r darn o gefnffordd yr A470 Caerdydd i Llangurig sy’n ymestyn o bwynt 25 o fetrau i’r de-ddwyrain o ganolbwynt ei chyffordd â’r B4518 St Harmon Road hyd at bwynt 200 metr i’r gogledd-orllewin o ganolbwynt y fynedfa i gerbydau i Barc Carafannau a Gwersylla Wyeside yn Rhaeadr Gwy, Powys.

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o’r gefnffordd.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, reidio unrhyw feic pedal ar y darn o’r gefnffordd.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, farchogaeth nac arwain unrhyw geffyl ar y darn o’r gefnffordd.

6. Ni fydd y gwaharddiadau yn erthyglau 3, 4 a 5 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

7. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“the trunk road” (“*y gefnffordd*”) means the length of the A470 Cardiff to Llangurig trunk road that extends from a point 25 metres south-east of the centre-point of its junction with the B4518 St Harmon Road to a point 200 metres north-west of the centre-point of the vehicular access to Wyeside Caravan & Camping Park at Rhayader, Powys;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 07:00 hours on 5 March 2022 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibitions

3. No person may, during the works period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road.

5. No equestrian may, during the works period, ride or lead any horse on the length of the trunk road.

Application

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

7. The maximum duration of this Order is 18 months.
