Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer y darn perthnasol o gefnffordd yr A5, wedi eu bodloni y dylid gwahardd traffig ar ddarnau penodedig o'r gefnffordd oherwydd y tebygolrwydd o berygl i'r cyhoedd sy'n deillio o gludo llwythi anwahanadwy annormal.

The Welsh Ministers, as traffic authority for the relevant length of the A5 trunk road, are satisfied that traffic on specified lengths of the trunk road should be prohibited by reason of the likelihood of danger to the public arising from the transportation of abnormal indivisible loads.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

**Title and commencement**

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A5 (Llangollen a Chorwen, Sir Ddinbych) (Gwahardd Aros, Llwytho a Dadlwytho Dros Dro) 2022 a daw'r Gorchymyn hwn i rym ar 25 Ebrill 2022.

1. The title of this Order is the A5 Trunk Road (Llangollen and Corwen, Denbighshire) (Temporary Prohibition of Waiting, Loading & Unloading) Order 2022 and this Order comes into force on 25 April 2022.

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw unrhyw gerbyd sy’n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â’r gwaith o gludo’r llwythi anwahanadwy annormal sy’n arwain at y Gorchymyn hwn;

ystyr “cyfnod y cludo” (“*transportation period*”) yw cyfnodau ysbeidiol sy’n dechrau am 00:01 o’r gloch ar 25 Ebrill 2022 ac sy’n dod i ben pan fydd y gwaith o symud y llwythi anwahanadwy annormal wedi ei gwblhau;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A5 Llundain i Gaerdybi.

## Gwaharddiad

3. Ni chaiff neb, ac eithrio yn ôl cyfarwyddyd neu â chaniatâd cwnstabl heddlu, swyddog cymorth cymunedol yr heddlu neu swyddog gorfodi sifil, beri na chaniatáu i unrhyw gerbyd aros, llwytho na dadlwytho ar y darnau o’r gefnffordd a bennir yn yr Atodlen i’r Gorchymyn hwn yn ystod cyfnod y cludo.

4. Ni fydd y gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

## YR ATODLEN

Y darnau o ddwy ochr y gefnffordd o’r enw Berwyn Road, Llangollen, Sir Ddinbych sy’n ymestyn tua’r gorllewin o bwynt 43 o fetrau i’r gorllewin o ganolbwynt ei chyffordd â Heol y Farchnad am bellter o 215 o fetrau.

“exempted vehicle” (“*cerbyd esempt*”) means any vehicle being used by the emergency services or in connection with the transportation of the abnormal indivisible loads giving rise to this Order;

“the trunk road” (“*y gefnffordd*”) means the A5 London to Holyhead trunk road;

“transportation period” (“*cyfnod y cludo*”) means intermittent periods commencing at 00:01 hours on 25 April 2022 and ending when all movement of the abnormal indivisible loads has been completed.

## Prohibition

3. No person may, except upon the direction or with the permission of a police constable, police community support officer or civil enforcement officer, cause or permit any vehicle to wait, load or unload during the transportation period on the lengths of the trunk road specified in the Schedule to this Order.

## Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

## Duration of this Order

5. The maximum duration of this Order is 18 months.

## SCHEDULE

The lengths of both sides of the trunk road known as Berwyn Road, Llangollen, Denbighshire that extends westwards from a point 43 metres west of the centre-point of its junction with Market Street for a distance of 215 metres.

Ochr ddeheuol y darn o'r gefnffordd o'r enw Heol Llundain, Corwen, Sir Ddinbych sy'n ymestyn o bwynt 27 o fetrau i'r gorllewin o ganolbwynt ei chyffordd â'r lôn sy'n arwain at Brookside Cottages hyd at bwynt 50 metr i'r gorllewin o'r gyffordd honno.

Ochr ddeheuol y darn o'r gefnffordd o'r enw Heol Llundain, Corwen, Sir Ddinbych sy'n ymestyn o bwynt 95 o fetrau i'r gorllewin o ganolbwynt ei chyffordd â'r lôn sy'n arwain at Brookside Cottages hyd at bwynt 128 o fetrau i'r gorllewin o'r gyffordd honno.

Ochr ddeheuol y darn o'r gefnffordd o'r enw Stryd y Bont, Corwen, Sir Ddinbych sy'n ymestyn o bwynt 138 o fetrau i'r gorllewin o ganolbwynt ei chyffordd â Lôn Las hyd at bwynt 197 o fetrau i'r gorllewin o'r gyffordd honno.

The southern side of the length of the trunk road known as London Road, Corwen, Denbighshire that extends from a point 27 metres west of the centre-point of its junction with the lane leading to Brookside Cottages to a point 50 metres west of that junction.

The southern side of the length of the trunk road known as London Road, Corwen, Denbighshire that extends from a point 95 metres west of the centre-point of its junction with the lane leading to Brookside Cottages to a point 128 metres west of that junction.

The southern side of the length of the trunk road known as Bridge Street, Corwen, Denbighshire that extends from a point 138 metres west of the centre-point of its junction with Green Lane to a point 197 metres west of that junction.
