Thank you for your reconsultation email dated 18/3/2021 relating to DM/2020/01805.

I sincerely appreciate your efforts in attempting to resolve this quite complex and sensitive matter of privacy and would refer you back to my previous comments and your actions relating to privacy of overlooking windows on the north elevation of the applicant's property. In that regard I still await confirmation that you will enforce the use of permanently obscured glass on those windows, and not merely a film stuck on the panes of glass. I recall that the windows should also be permanently unopenable.

In the event that you decide that the proposed enormous (2.5m x 3.8m) balcony alterations are deemed acceptable I have the following comments to make regarding the privacy screen proposals:-

Firstly the height of the proposed "privacy screen" is insufficient. I am not particularly tall but would easily be able to see above it as described as 1.8 metres above the balcony floor structure. A 2 metre height would be adequate and fit for purpose.

Secondly the proposed "timber slat" construction is insufficiently described and seems to be easily removable. I would suggest a permanent fitting of the opaque glass to the height of 2 metres.

Please let me know if any of my comments need clarification.
