(Amendment) (No. 2) Directions 2022**

The Welsh Ministers, in exercise of the powers conferred on them by sections 10, 12(3) and 203(9) and (10) of the National Health Service (Wales) Act 2006⁽¹⁾, make the following Directions.

Title, application and commencement

1.—(1) The title of these Directions is the Primary Care (Contracted Services: Immunisations) (Amendment) (No. 2) Directions 2022.

(2) These Directions are given to Local Health Boards.

(3) These Directions come into force on 25 August 2022.

Amendment of the Primary Care (Contracted Services: Immunisations) Directions 2021

2.—(1) The Primary Care (Contracted Services: Immunisations) Directions 2021⁽²⁾ are amended as follows.

(2) In Direction 2—

(a) in the definition of “Covid-19 vaccine” for “the Moderna vaccines, Novavax vaccine, Oxford/Astra-Zeneca vaccine, Pfizer-BioNTech vaccine or Vaccine Janssen” substitute “any vaccine authorised under the Human Medicines Regulations 2012⁽³⁾ for the vaccination or immunisation of individuals at risk from Covid-19”; and

(b) omit the definitions of—

(i) “Moderna vaccine”;

(ii) “Novavax vaccine”;

(iii) “Oxford/Astra-Zeneca vaccine”;

(iv) “Pfizer-BioNTech vaccine”; and

(v) “Vaccine Janssen”.

(3) In Direction 4—

- (a) in paragraph (4)(a)(iv) after “under” in the second place it occurs insert “the”;
 - (b) for paragraph (4)(c)(iii) substitute “adheres to all relevant conditions specified in the summary of product characteristics published by the manufacturers of each Covid-19 vaccine.”;
 - (c) at the end of paragraph (4)(e)(i) insert “and”;
 - (d) in paragraph (4)(e)(ii) for “, and” substitute “.”; and
 - (e) omit paragraph (4)(e)(iii).
- (4) In Direction 7(1)(a)(iv) before “vaccine” insert “Covid-19”.
- (5) In Schedule 1 (Primary Care Contracted Services: Immunisations (Covid-19 Vaccines) Specification)—
- (a) in the last paragraph of paragraph 1 (Introduction) for “the Moderna vaccine, the Novavax vaccine, the Oxford-Astra/Zeneca vaccine, the Pfizer-BioNTech vaccine and the Vaccine Janssen Covid-19 vaccines” substitute “vaccines authorised under the Human Medicines Regulations 2012 for the vaccination or immunisation of individuals at risk from Covid-19”;
 - (b) in paragraph 2 (Background) omit the words from “The Moderna and Pfizer-BioNTech vaccines” to “Matrix-M is an adjuvant added to enhance the immune response to the vaccine.”; and
 - (c) omit paragraph 7(b).

Revocations

3. The Primary Care (Contracted Services: Immunisations) (Amendment) Directions 2021⁽¹⁾ are revoked.
