

**GORCHYMYN CEFNFFORDD YR A458
(BUTTINGTON CROSS, TAL-Y-BONT, POWYS)
(GWAHARDD CERBYDAU DROS DRO)
2022**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A458, neu gerllaw iddi, yn Buttington Cross, Tal-y-bont yn Sir Powys.

Effaith y Gorchymyn fydd gwahardd dros dro bob cerbyd, ac eithrio'r rheini sy'n cael eu defnyddio gan y gwasanaethau brys ac ar gyfer y gwaith, rhag mynd ar y darn o gerbyttffordd tua'r gorllewin y gefnffordd sy'n ymestyn o'i chyffordd â'r B4388 wrth y tŷ tafarn o'r enw y Green Dragon hyd at ei chyffordd â Chylchfan Buttington Cross.

Y llwybr arall ar gyfer pob cerbyd sy'n dymuno teithio tua'r gorllewin fydd mynd ar hyd y B4388 tua'r de, y B4381 tua'r gorllewin i Gylchfan Station Road a'r A483 tua'r gogledd i Gylchfan Buttington Cross.

Bydd y gwaharddiad dros dro, y codir arwyddion priodol yn ei gylch, yn weithredol o 09:00 ar 3 Hydref 2022 hyd 17:00 ar 7 Hydref 2022 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod yr amseroedd a'r dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A458 TRUNK ROAD (BUTTINGTON
CROSS, BUTTINGTON, POWYS)
(TEMPORARY PROHIBITION OF VEHICLES)
ORDER 2022**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to undertake works on or near the A458 trunk road at Buttington Cross, Buttington in the County of Powys.

The effect of the Order will be to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the length of the westbound carriageway of the trunk road that extends from its junction with the B4388 adjacent to the public house known as the Green Dragon to its junction with Buttington Cross Roundabout.

The alternative route for all vehicles wishing to travel westbound will be to proceed via the B4388 southbound, B4381 westbound to Station Road Roundabout and A483 northbound to Buttington Cross Roundabout.

The temporary prohibition, which will be signed accordingly, will operate from 09:00 hours on 3 October 2022 until 17:00 hours on 7 October 2022 or until the temporary traffic signs are permanently removed.

Although the proposed Order is only expected to operate during the times and dates specified above it will remain valid for a maximum period of 18 months as a contingency should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
