ATISN 16696 - Births Data

Thank you for your request to the Welsh Government for information received on 28 September 2022 relating to baby deaths and brain injuries in Wales which will be dealt with under the Freedom of Information Act (2000) (FOIA). You have requested the following:

How many full-term babies (at least 37+0 completed weeks of gestation) have been born in Wales per year (calendar or financial year) since 2018, per outcome, for each of the following outcomes:

- Intrapartum stillbirth: when the baby was thought to be alive at the start of labour but was born with no signs of life.
- Early neonatal death: when the baby died within the first week of life (i.e. days 0–6) of any cause.
- Severe brain injury diagnosed in the first 7 days of life, when the baby:
 - Was diagnosed with grade III hypoxic ischaemic encephalopathy (HIE) OR
 - Was therapeutically cooled (active cooling only) OR
 - Had decreased central tone AND was comatose AND had seizures of any kind.

Our Response

 The Welsh Government only holds data on birth outcome and gestation through an extract from the National Community Child Health Database, so we are only able to answer the first part of the request.

The data for stillbirths born at gestations 37+0 completed weeks of gestation is provided below in Table 1.

Table 1: Number of full term live and stillbirths in Wales, 2018 to 2021

Full Term Stillbirths

2018, 41 2019, 36 2020, 32 2021, 29

 combined.
