Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A4076, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd Gwasanaeth Sul y Cofio sy'n cael ei gynnal ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A4076 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited due to the holding of the Remembrance Sunday Memorial Service being held on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 16A o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

Enwi a chychwyn

Title and commencement

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4076 (Hamilton Terrace a Great North Road, Aberdaugleddau, Sir Benfro) (Gwahardd Cerbydau Dros Dro) 2022 a daw'r Gorchymyn hwn i rym ar 13 Tachwedd 2022.

1. The title of this Order is the A4076 Trunk Road (Hamilton Terrace and Great North Road, Milford Haven, Pembrokeshire) (Temporary Prohibition of Vehicles) Order 2022 and this Order comes into force on 13 November 2022.

Interpretation

2. Yn y Gorchymyn hwn—

2. In this Order—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw:

“closure period” (“*y cyfnod cau*”) means that period commencing at 10:00 hours on 13 November 2022 and ending when the temporary traffic signs are permanently removed;

- (i) unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys;

- (ii) unrhyw gerbyd sy'n cael ei ddefnyddio mewn cysylltiad â gwaith ar y ffordd neu oleuadau neu arwyddion traffig neu waith brys i unrhyw garthffos neu i unrhyw brif bibell neu gyfarpar ar gyfer cyflenwi nwy, dŵr neu drydan, neu gyfarpar telathrebu yn y darn o'r ffordd o dan sylw, neu mewn unrhyw dir cyfagos; neu
- (iii) unrhyw gerbyd sy'n cael ei ddefnyddio gan swyddog awdurdodedig i gefnogi Gwasanaeth Sul y Cofio ac am resymau diogelwch y gwasanaeth;

ystyr "y cyfnod cau" ("*closure period*") yw'r cyfnod hwnnw sy'n dechrau am 10:00 o'r gloch ar 13 Tachwedd 2022 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr "y gefnffordd" ("*the trunk road*") yw cefnffordd yr A4076 Hwlffordd i Aberdaugleddau.

Gwaharddiad

3. Ni chaiff neb, yn ystod y cyfnod cau, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o'r gefnffordd a elwir yn Hamilton Terrace a Great North Road sy'n ymestyn i gyfeiriad cyffredinol y dwyrain o gyffordd Hamilton Street â Dartmouth Street hyd at gyffordd Great North Road â Charles Street.

Cymhwyso

4. Ni fydd y gwaharddiad yn erthygl 3 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

Cyfnod Para'r Gorchymyn hwn

5. Bydd y Gorchymyn hwn yn para am 1 diwrnod ar y mwyaf.

"exempted vehicle" ("*cerbyd esempt*") means:

- (i) any vehicle being used by the emergency services;
- (ii) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned; or
- (iii) any vehicle being used by an authorised official in support of and for safety reasons of the Remembrance Sunday Memorial Service.

"the trunk road" ("*y gefnffordd*") means the A4076 Haverfordwest to Milford Haven trunk road.

Prohibition

3. No person may, during the closure period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road known as Hamilton Terrace and Great North Road that extends in a general easterly direction from the junction of Hamilton Street with Dartmouth Street to the junction of Great North Road with Charles Street.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 1 day.
