### **ATISN 17198 – Thumb Loop Gowns**

Thank you for your request to the Welsh Government for information under the Freedom of Information Act (2000) received on 23 March 2023. You have requested the following:

1. The date / dates and quantities of each delivery of thumb loop gowns procured by the Welsh NHS SSP.
2. Which company supplied the thumb loop gowns to the Welsh NHS SSP.
3. The price paid by the Welsh NHS SSP for the thumb loop gowns that they procured.
4. The stock levels for thumb loop gowns held by Welsh NHS SSP's central stock holding for each of the last 6 months until end of January 2023.
5. Any email correspondence between Jonathan Irvine Welsh NHS SSP and Alexandra Workwear ([alexandra.co.uk](http://alexandra.co.uk)) mentioning thumb loop gowns.
6. What standard the thumb loop gowns ordered by Welsh NHS SSP met when they were ordered.
7. What is the shelf life of thumb loop gowns that the Welsh NHS SSP central stock holding have in stock.
