Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A470, wedi eu bodloni y dylid gwahardd traffig ar ddarn penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A470 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1) a (4) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A470 (Llanelwedd, Powys) (Gwahardd Traffig Dros Dro) 2023 a daw'r Gorchymyn hwn i rym ar 17 Mawrth 2023.

Title and commencement

1. The title of this Order is the A470 Trunk Road (Llanelwedd, Powys) (Temporary Prohibition of Traffic) Order 2023 and this Order comes into force on 17 March 2023.

Dehongli

2. Yn y Gorchymyn hwn—

ystyr "cerbyd esempt" ("*exempted vehicle*") yw unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;

Interpretation

2. In this Order—

"exempted vehicle" ("*cerbyd esempt*") means any vehicle being used by the emergency services or in connection with the works giving rise to this Order;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy’n dechrau am 19:00 o’r gloch ar 17 Mawrth 2023 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw’r darn o gefnffordd yr A470 Caerdydd i Llangurig yn Llanelwedd, Powys sy’n ymestyn o’i chyffordd ag ochr orllewinol cylchfan yr A470/A483 hyd at bwynt 30 o fetrau i’r de-ddwyrain o ganolbwynt ei chyffordd â’r ffordd sirol sy’n arwain at y brif fnyddfa i gerbydau i Faes Sioe Frenhinol Cymru.

3. Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd ar y darn o’r gefnffordd a bennir yn erthygl 2 o’r Gorchymyn hwn.

4. Ni chaiff neb, yn ystod cyfnod y gwaith, reidio unrhyw feic pedal ar y darn o’r gefnffordd a bennir yn erthygl 2 o’r Gorchymyn hwn.

5. Ni chaiff neb, yn ystod cyfnod y gwaith, gerdded ar y darn o’r gefnffordd a bennir yn erthygl 2 o’r Gorchymyn hwn.

6. Ni chaiff neb, yn ystod cyfnod y gwaith, farchogaeth ar y darn o’r gefnffordd a bennir yn erthygl 2 o’r Gorchymyn hwn.

7. Ni chaiff neb, yn ystod cyfnod y gwaith, ganiatáu i unrhyw dda byw fynd ar y darn o’r gefnffordd a bennir yn erthygl 2 o’r Gorchymyn hwn.

Cymhwys

8. Nid yw’r gwaharddiadau yn erthyglau 3, 4, 5, 6 a 7 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

Cyfnod para’r Gorchymyn hwn

9. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

“the trunk road” (“*y gefnffordd*”) means the length of the A470 Cardiff to Llangurig trunk road at Llanelwedd, Powys that extends from its junction with the western side of the A470/A483 roundabout to a point 30 metres south-east of the centre-point of its junction with the county road that leads to the main vehicle access of the Royal Welsh Showground;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 19:00 hours on 17 March 2023 and ending when the temporary traffic signs for each period of works are permanently removed.

Prohibitions

3. No person may, during the works period, drive any vehicle on the length of the trunk road specified in article 2 of this Order.

4. No person may, during the works period, ride any pedal cycle on the length of the trunk road specified in article 2 of this Order.

5. No pedestrian may, during the works period, proceed on the length of the trunk road specified in article 2 of this Order.

6. No equestrian may, during the works period, proceed on the length of the trunk road specified in article 2 of this Order.

7. No person may, during the works period, permit any livestock to proceed on the length of the trunk road specified in article 2 of this Order.

Application

8. The prohibitions in articles 3, 4, 5, 6 and 7 apply only during such times and to such extent as indicated by traffic signs.

Duration of this Order

9. The maximum duration of this Order is 18 months.
