- Has Colegau Cymru and Black Leadership Group commissioned and published their review on policies and procedures in FE and adult learning sector? This was due by March 2023. Please can you signpost me to this document that will have been "completed and published" by March 2023.

This review took the form of a scoping study by ColegauCymru and the Black Leadership Group, to identify recommendations that could inform future work on antiracism in the further education sector. The report of this study was published in July 2022 and is available here:

• Has HEFCW, University Wales, Welsh HE institutions and Unions established an antiracism network across the HE sector?

This network has been established and is funded by HEFCW. It held its first meeting in February 2023.

• Please provide the Welsh language commissioner's response to the Anti-racism Wales action plan consultation.

This information is not held by the Welsh Government.

• Has a review been undertaken on PGCE for FE incentives programme, and where has this review been published on the ethnicity of current practitioners? Have you reached this goal?

A review has been undertaken on the FE Incentives Programme, and officials are awaiting the final report. There is no intention to publish the report as it has been undertaken to inform policy development. Further information on any changes to the FE Incentives programme will be published in due course.

authorities, as well as organisations providing informal ESOL provision and wider supporting agencies.
