## **ATISN 17232 - Anti-racist Wales Action Plan - Information on the Welsh Language**

### **Information requested**

Thank you for your request which I received on 06 March 2023. You asked:

1. Has the Welsh Government and the Welsh Language Partnership Council's Equality Inclusion and Diversity Sub-group been successful in gaining a better understanding into the lived experience of ethnic minority speakers by March 2023, and where can the public access the findings?

2. Has the Welsh Government been successful in updating grant funding arrangements for grant recipients?

3. Has the action relating to the Centre for Learning Welsh been successfully implemented by March 2023, and where is the published review following the commission?

i. How does the government measure this?

4. Have grant funded organisations been successful in the analysis of data of Black, Asian and Minority Ethnic children who attend Welsh medium schools, and where can we access the strategies?

5. Was the government successful in commissioning the development of multilingual anti-racist resources and case studies by December 2022?

Although the information relating to your Freedom of Information request is not recorded, I am able to confirm that officials have undertaken work to fulfil the commitments made in relation to the *Anti-racist Wales Action Plan* and *Cymraeg 2050*.

The Welsh Language Partnership Council's Equality, Inclusion and Diversity Sub-group has met several times and continues to be a valuable forum for gaining a better understanding of the lived experience of ethnic minority Welsh speakers.

We are working with grant recipients to put arrangements in place for the 2023-24 financial year in relation to the commitments made in the *Anti-racist Wales Action Plan*.

Officials are in continuous dialogue with the National Centre for Learning Welsh about their work in this area and welcome the launch of the *Croeso i Bawb* project.
