The Nation of Sanctuary Refugee and Asylum Seeker Plan has always been inclusive of all refugees and asylum seekers. Migration policy is not devolved, so solutions to some important issues lie with the UK Government. However, we must make clear our opposition to many aspects of the Nationality and Borders Act which will have a detrimental impact on Wales and any asylum seekers placed in our communities. We are continuing to liaise with UK Government about these issues.
