Thank you for your further request to the Welsh Government for information received on 22 April 2023 which will be dealt with under the Freedom of Information Act (2000) (FOIA). I have interpreted your request as follows:

What pharmaceutical protocols were recommended for anticipatory medications that might be needed in the treatment of COVID-19.

Response

A number or UK-wide clinical access policies provided recommendations on the use therapeutics agents for the treatment of COVID-19 in hospitalised and non-hospitalised patients. These are all available to access at COVID-19 therapies - alerts and advice - All Wales Therapeutics and Toxicology Centre (nhs.wales)

You also commented that some of the links do not work in the PDF documents we provided as part of the response to your original request. We only have a record of the documents provided to you and do not have the information that was hyperlinked in documents one and two. This is because the NHS in Wales used a national digital platform to provide the guideline to NHS clinical teams. The national digital platform was made available until 31 March 2023 to NHS clinicians that had registered with the digital platform.

Next Steps

The request you sent me contains personal information about you - for example, your name and address. The Welsh Government will be the data processor for this information and, in accordance with the General Data Protection Regulation, it will be processed in order to fulfil our public task and meet our legal obligations under the Act to provide you with a response.

We will only use this personal information to deal with your request and any matters which arise as a result of it. We will keep your personal information and all other information relating to your request for three years from the date on which your request is finally closed. Your personal information will then be disposed of securely.

Under data protection legislation, you have the right:

- · to be informed of the personal data we hold about you and to access it
- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to (in certain circumstances) data portability
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
