ATISN 18606 – One Planet Council review of One Planet Development policy

Thank you for your request which I received on 15 June 2023. You asked for:

All correspondence between the One Planet Council and Welsh Government, specifically relating to the "Review of One Planet Developments in Wales 2010 - 2021". The documentation should include a copy of the cover letter from the One Planet Council to Welsh Government enclosing a copy of their review findings.

Our response

- 1. In June 2021 the One Planet Council wrote to the Minister for Climate Change to say that they were intending to carry out a review of the Welsh Government's One Planet Development Policy. In this letter they asked for suggestions on what their review might helpfully look at. The Welsh Government's response listed a number of OPD topics that we thought would be useful in this respect. This correspondence is set out in Appendix 1 documents 1 and 2 (referenced TO/JJ/10394/21). No further input was provided.
- 2. In April 2022 the Minister for Climate Change received an invitation from the One Planet Council to attend the launch of their One Planet Development Review. The Minister did not attend the launch please see Appendix 1 documents 3, 4 and 5. An invitation was also sent to the Chief Planner, see documents 6 and 7. Neither the Chief Planning nor any Planning Department staff attended the launch.
- 3. We cannot find a record of having received a copy of the One Planet Council's OPD Review, however, a copy was downloaded from the One Planet Council's website.

Success of One Planet Developments in Wales

The One Planet Council is an independent voluntary body which works to promote and support One Planet Development, a planning policy of the Welsh Government. We write to offer our congratulations on your re-election to the Senedd and your new job as Minister for Climate Change, and to update you on our activities and progress.

We are pleased to see the creation of a climate change ministry putting the climate and ecological emergency at the forefront of Welsh policymaking, a move which continues Welsh leadership on climate and our responsibility to future generations. The One Planet Development (OPD) policy has been a small but important part of this leadership since its introduction with the publication of TAN6 in 2010 and the OPD Practice Guidance in 2012, and it has been making waves both within and beyond Wales. We at the One Planet Council have been supporting OPD practitioners, planning departments, other professionals, and potential applicants with training, advice, and assistance. Further afield, we have supported English council areas such as Cornwall and Dartmoor to adopt policies inspired by OPD, and we have also provided help to campaigners in Ireland and members of parliament from New Zealand who have heard of Wales' leadership and want to learn from our experience.

Though the policy is relatively new, some OPDs are now reaching the end of their 5-year "set up period" and we are starting to see strong positive evidence of their contributions to biodiversity, local economies and communities, and importantly the low ecological footprint that can be achieved through innovative low impact design, active travel, community engagement, and renewable energy. This year, therefore, we are conducting a review of OPD in Wales and the impact of this policy since its introduction. We will be highlighting success, identifying challenges, and making recommendations for the future development of the policy and its implementation going forward. We are presently structuring the review and could take on board suggestions if you or your officers have any specific areas of interest you feel we should address.

We wish you every success in your new role and look forward to your input as we conduct our review.

Thank you for your email of 11 June, about the One Planet Council's proposed review of One Planet Development (OPD). This matter falls within the responsibilities of Julie James MS, Minster for Climate Change. I have been asked to reply.

We appreciate you informing us of this review and welcome the opportunity to provide suggestions regarding its content, and to seeing any outcomes or recommendations emanating from the final report.

In respect of topics to cover, this very much depends on the scope of your study. It might be useful to see a proposed structure which we could then offer further suggestions for if necessary. Having said that, the following suggestions come to mind, development management data (granted, refused, appeals, determination period etc. The Welsh Government only collects data on applications granted and refused), opinions from those undertaking OPD projects and local planning authorities (LPAs) regarding the operation of the monitoring process and application of the toolkit, examples of ecological footprint figures being achieved by OPDs, and instances where OPD projects have failed or enforcement action has been taken by the LPA.
