### **Request for Information - ATISN 18746**

Thank you for your request for information which I received on 18 July.

#### **Your request**

You have asked for the following information:

1. The average cost to Natural Resources Wales (NRW) to issue a permit for the disposal of waste sheep dip through landspreading.
2. The average cost to NRW to amend a permit for the disposal of waste sheep dip through landspreading
3. The average cost to NRW to surrender a permit for the disposal of waste sheep dip through landspreading
4. The average cost to NRW to transfer a permit for the disposal of waste sheep dip through landspreading
5. The total number of applications received by NRW for new permits for the disposal of waste sheep dip through landspreading since 1st April 2013
6. The total number of applications received by NRW to amend, surrender or transfer a permit for the disposal of waste sheep dip through landspreading since 1st April 2013
7. The number of visits made by NRW to waste sheep dip disposal sites per year between 1st April 2013 and 1st April 2023.

You also have the right to complain to the Information Commissioner. However, please note that the Commissioner will not normally investigate a complaint until it has been through our own internal review process.

The request you sent me contains personal information about you - for example, your name and email address.
