Complaint in respect of ATISN 18676

Thank you for your request for internal review on the above request, which I received on 31 July 2023. You did not state in what way you were dissatisfied with our handling of your request in that message, but in your follow up of 1 August you stated:

that there were significant delays between responses and no effort to understand the request or to help with the request as set out and required by the FOI guidelines.

You also indicated that you would accept the information request in "percentage form." That is, a summary of the data.

Your request asked for:

Information on compensation paid to claimants relating to section 4 and 5 of A465 Head of the Valleys project. You requested a breakdown the information to include detail on injurious severance and value of Compulsory Purchase orders. In other words. What agreements have been made with claimants and what are the values, broken down in terms of how the compensation was allocated and calculated.

We interpreted this request to be financial compensatory information regarding payments to individuals in the above work.

Further to my acknowledgement letter of 1 August 2023, I confirm that I've now completed my internal review of your previous Freedom of Information (FOI) request.

We welcome receiving correspondence in Welsh. Any correspondence received in Welsh will be answered in Welsh and corresponding in Welsh will not lead to a delay in responding.

Following a thorough review of its handling, I **uphold** the original decision to withhold the release of financial compensatory information payments made to individuals in respect of the A465 road scheme. The rationale for my decision is shown below and a Chronology of your FOI request can be found at Appendix A.

While reviewing your case I noted a perceived lack of clarity around your FOI request that prompted a number of exchanges between yourself and the Welsh Government case handler. No doubt this had the potential for frustration for both parties, however I did not detect any obduracy on the part of the case handler given in their letter to you dated 6 July they sought to help you refine your FOI request by: i) encouraging you to "focus only on precise pieces of information you want" and ii) offering to arrange a face to face meeting with yourself, that you did not respond to. (I understand that other offers to meet have also not been taken up by yourself.)

Despite these exchanges, the FOI request was reviewed and concluded in a timely manner and within the statutory deadline, and officials made repeated requests for clarification in an effort to assist you.

. As part of my review I did question whether some indicative anonymised information may be releasable to you. However it appears that discussions with landowners regarding compensation, due to related Compulsory Purchase Order/s (CPO), are still very much in their infancy We therefore do not hold average or aggregate data at this time.
