ATISN 18864 – Why Chemtrails?

Thank you for your request for the release of information, under the Environmental Information Regulations 2004, which I received on 22 August. You asked for information on Welsh Government geo-engineering programmes including:

- a) the legal basis for Welsh Government conducting geo-engineering;
- b) any consideration given to the Geneva Conventions;
- c) any consideration given to the Nuremberg Code of Ethics on permissible medical experimentation;
- d) the contents of the sprays Welsh Government has used for geoengineering and any tests carried out on those chemicals;
- e) details of the contractors Welsh Government are using to test and spray chemicals for geo-engineering;
- f) has Welsh Government had contact with investment companies in relation this programme;
- g) what effects will the Welsh Government geo-engineering programme have on the weather:
- h) the quantity of chemicals Welsh Government are using for geo-engineering per day;
- i) what responsibility does Welsh Government hold for damages or injury caused by our geo-engineering activities.

Our response

Following a search of our paper and electronic records, I have established that the information you requested is not held by the Welsh Government.

The Welsh Government is not conducting geo-engineering and policy in this area is not devolved to Welsh Ministers but is reserved to UK Government. May I refer you to their
