

**GORCHYMYN CEFNFFORDD YR A479 (CWMDU, TRETŴR A PHARC GLAN-WYSG, POWYS) (FFORDD GYFYNGEDIG, TERFYNAU CYFLYMDER 30 MYA, 40 MYA A 50 MYA) 2023**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn drwy arfer eu pwerau o dan adrannau 82(1) a (2), 83(1), 84(1)(a) a (2) a 124 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984, a pharagraff 27 o Atodlen 9 iddi, sy'n dod i rym ar 10 Awst 2023.

Yn rhinwedd dirymu Gorchymyn Cefnffordd yr A479 (Tretŵr a Chwm-du, Powys) (Terfyn Cyflymder 40 mya) 1996 (O.S. 1996/1574), mae'r Gorchymyn yn ailgyflwyno'r statws ffordd gyfyngedig drwy bentref Tretŵr ac yn dirymu'r terfyn cyflymder presennol o 40 mya. Mae hefyd yn cyflwyno terfyn cyflymder o 30 mya ym mhob pen o'r pentref lle nad oes statws ffordd gyfyngedig yn rhinwedd goleuadau stryd, yn cadw'r terfyn cyflymder o 40 mya drwy bentref Cwm-du (gyda disgrifiad diwygiedig yn y Gorchymyn i gyd-fynd â'r arwyddion presennol) ac yn cyflwyno terfyn cyflymder o 50 mya wrth ddynesu at bentref Tretŵr o gyfeiriad y de o'i chyffordd â'r A40 wrth Barc Glan-wysg.


**THE A479 TRUNK ROAD (CWMDU, TRETOWER AND GLANUSK PARK, POWYS) (RESTRICTED ROAD, 30 MPH, 40 MPH AND 50 MPH SPEED LIMITS) ORDER 2023**

The Welsh Ministers have made an Order in exercise of their powers under sections 82(1) and (2), 83(1), 84(1)(a) and (2) and 124 of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on 10 August 2023.

By virtue of the revocation of the A479 Trunk Road (Tretower and Cwmdu, Powys) (40 mph Speed Limit) Order 1996 (S.I. 1996/1574), the Order re-introduces the restricted road status though the village of Tretower and revokes the current 40 mph speed limit. It also introduces a 30 mph speed limit at either end of the village, where there is no restricted road status by virtue of street lighting, retaining the 40 mph speed limit through the village of Cwmdu (with an amended description within the Order to match the current signage) and introduces a 50 mph speed limit on the southern approach to the village of Tretower from its junction with the A40 at Glanusk Park.

Y darn hwnnw o'r gefnffordd i'r de-ddwyrain o Dretŵr sy'n ymestyn o bwynt 75 o fetrau i'r de-ddwyrain o ganolbwynt ei chyffordd â ffordd sirol yr U0491 i gyfeiriad de-ddwyreiniol i'w chyffordd â'r A40 ym Mharc Glan-wysg.

from a point 25 metres south-east of the centre point of its junction with the C0115 county road in a south-easterly direction to a point 75 metres south-east of the centre point of its junction with the U0491 county road.

### **SCHEDULE 2**

That length of the trunk road at Cwmdu that extends from a point 600 metres south of the centre point of its junction with the C112 county road in a northerly direction to a point 135 metres north of the centre point of its junction with the C112 county road.

### **SCHEDULE 3**

That length of the trunk road southeast of Tretower that extends from a point 75 metres south-east of the centre-point of its junction with the U0491 county road in a south-easterly direction to its junction with the A40 at Glanusk Park.
