The M4 Motorway (Junction 25A
(Grove Park) to Junction 26
(Malpas), Newport) (Temporary
Prohibition of Vehicles) Order
2023

Made 29 August 2023
Coming into force 8 September 2023

The Welsh Ministers, as traffic authority for the relevant length of the M4 motorway, are satisfied that traffic on specified lengths of the motorway should be prohibited because of the likelihood of danger to the public and the workforce.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by sections 14(1) and (4) of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the M4 Motorway (Junction 25A (Grove Park) to Junction 26 (Malpas), Newport) (Temporary Prohibition of Vehicles) Order 2023 and this Order comes into force on 8 September 2023.

Interpretation

2. In this Order:

(1) 1984 c. 27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c. 26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

ystyr “cyfnod y gwaith” (“*works period*”) yw'r cyfnod sy'n dechrau am 20:00 o'r gloch ar 8 Medi 2023 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y draffordd” (“*the motorway*”) yw traffordd yr M4 Llundain i Dde Cymru.

Gwahardd Pob Cerbyd Dros Dro

1. Y darn o gerbytffordd tua'r gorllewin traffordd yr M4 sy'n ymestyn o drwyniad ffisegol y ffordd ymadael tua'r gorllewin wrth Gyffordd 25A (Grove Park) hyd at drwyniad ffisegol y ffordd ymuno tua'r gorllewin wrth Gyffordd 26 (Malpas).

2. Y darn o gerbytffordd tua'r dwyrain traffordd yr M4 sy'n ymestyn o drwyniad ffisegol y ffordd ymadael tua'r dwyrain wrth Gyffordd 26 (Malpas) hyd at drwyniad ffisegol y ffordd ymuno tua'r dwyrain wrth Gyffordd 25A (Grove Park).

“the motorway” (“*y draffordd*”) means the M4 London to South Wales Motorway;

“works period” (“*cyfnod y gwaith*”) means the period commencing at 20:00 hours on the 8 September 2023 and ending when the temporary traffic signs are permanently removed.

Prohibition

3. No person may, during the works period, drive any vehicle on the lengths of the motorway specified in the Schedule to this Order.

Application

4. The prohibition in article 3 applies only during such times and to such extent as indicated by traffic signs.

Duration of this Order

5. The maximum duration of this Order is 18 months.

SCHEDULE

Temporary Prohibition of all Vehicles

1. The length of the westbound carriageway of the M4 motorway that extends from the physical nosing of the westbound exit slip road at Junction 25A (Grove Park) to the physical nosing of the westbound entry slip road at Junction 26 (Malpas).

2. The length of the eastbound carriageway of the M4 motorway that extends from the physical nosing of the eastbound exit slip road at Junction 26 (Malpas) to the physical nosing of the eastbound entry slip road at Junction 25A (Grove Park).

3. Y darn o'r ffordd ymuno tua'r dwyrain wrth Gyffordd 26 (Malpas) sy'n ymestyn o'i chyffordd â Chyfnewidfa Malpas yr A4051 hyd at ei chysylltiad â cherbytffordd tua'r dwyrain traffordd yr M4.
4. Y darn cyfan o ffordd gyswilt tua'r de yr A449 i ffordd ymuno tua'r gorllewin yr M4 wrth Gyffordd 24 (Coldra) o'r man lle y mae'n ymwahanu oddi wrth lôn neilltuedig tua'r dwyrain yr M4 hyd at gylchfan Cyffordd 24 (Coldra) yr A449.
3. The length of the eastbound entry slip road at Junction 26 (Malpas) that extends from its junction with the A4051 Malpas Interchange to its connection with the eastbound carriageway of the M4 motorway.
4. The entire length of the A449 southbound Link to the M4 westbound entry slip road at Junction 24 (Coldra) from where it diverges from the M4 eastbound dedicated lane to the Junction 24 (Coldra) A449 roundabout.
