**THE A465 NEATH TO ABERGAVENNY
TRUNK ROAD (SALEYARD AND
GLANBAIDEN JUNCTIONS) (30MPH SPEED
LIMIT) ORDER 202-**

The Welsh Ministers have made an Order in exercise of their powers under sections 84(1)(a), 84(2) and 124(1)(d) of, and paragraph 27 of Schedule 9 to, the Road Traffic Regulation Act 1984, which comes into force on *****202-.

The effect of the Order will be to introduce a 30 mph speed limit on the lengths of the A465 trunk road at Saleyard and Glanbaiden Junctions described in the Schedules to this Notice.

The A40 Trunk Road (Brecon Road and Monmouth Road, Abergavenny, Monmouthshire) (20 mph Speed Limit) Order 2022 S.I. 2022 No. 422 (W. 103) will be revoked by the made Order.

**SCHEDULE 1
A465 TRUNK ROAD
(GLANBAIDEN JUNCTION)**

The full circulatory of the A465 Neath to Abergavenny trunk road at Glanbaiden Junction in the County of Monmouthshire, including its junction leading to Courtyard Cottage for a distance of 30 metres and its junction with the B4246 for a distance of 19 metres.

**SCHEDULE 2
A465 TRUNK ROAD
(SALEYARD JUNCTION)**

The length of highway in the vicinity of Saleyard Junction in the County of Monmouthshire known as Main Road that extends from a point 20 metres north of its junction with the A465 eastbound exit slip road to its junction with Station Road and the A465 eastbound entry slip road.

The length of highway in the vicinity of Saleyard Junction in the County of Monmouthshire known as Station Road that extends from its junction with Main Road to the centre of its junction with the exit from Station Road bus stop layby.
