## **PLEASE NOTE**

1. Byelaw 12 of the former North Western and North Wales Sea Fisheries Committee (“NWNWSFC”) now has effect, to the extent that the Welsh Minsters could make that provision in a Statutory Instrument, as if made in a Statutory Instrument by the Welsh Ministers, by virtue of Article 13(3) of the Marine and Coastal Access Act 2009 (Commencement No. 1, Consequential, Transitional and Savings Provisions) (England and Wales) Order 2010 (S.I. 2010/630 (C.42)). By virtue of Articles 10(4) and 13(5) and (6) of that 2010 Order all functions formerly exercisable by NWNWSFC (pursuant to Byelaw 12) are, since 1 April 2010, now exercisable by the Welsh Ministers.
2. Any authorisation which may be issued as a result of this application will relate only to Byelaw 12 of the former NWNWSFC.
3. It is the Applicant’s responsibility to ensure compliance with all other relevant legislation (including fisheries and non-fisheries, domestic and European provisions). Particular attention is drawn to the Scallop Fishery (Wales) (No.2) Order 2010 (S.I. 2010/269)<sup>1</sup> as amended by The Sea Fishing (Miscellaneous Amendments) (Wales) Regulations 2019 (S.I. 2019/1332)<sup>2</sup>.

### ***Welsh Government Fisheries Control & Enforcement Branch Privacy Notice (please read before filling in the application form)***

**Your privacy is important to the Welsh Government and in line with the UK General Data Protection Regulations (UK GDPR) we have developed a Privacy Notice that covers why we collect and use your information. #### **1. Background**

The information we will collect and hold from your application may include your name, address, telephone/mobile number, email address, National Insurance number, evidence of required Health and Safety courses and evidence of your home address. On occasions where a photo permit is being applied for, we will also collect from you two passport size photographs.

Catch Return data you provide in line with legislation, will also be collected and held.

#### **2. What do we do with your information?**

The purpose of collecting this data is for Welsh Government to provide you with the fisheries licenses, permits and registrations you request from the Welsh Government.

Contact information is required to ensure that you receive up to date information regarding the opening and closing of fisheries and any other

important information deemed necessary for the safe management of a sustainable fishery.

Catch Returns are used to assist us in monitoring the fishery in the exercise of our official duty and to provide for the future viability of the fisheries concerned.

### **3. Who do we share your information with?**

The collected information may be shared with several Welsh Government Departments for marine and fisheries business. Where necessary your information may also be passed on to Statutory Bodies such as, but not confined to, Local Authorities or the Gangmasters and Labour Abuse Authority so they may contact you about matters concerning the regulation of fishing activity. Your data may also be accessed by agencies, authorised by Welsh Government, for the purpose of validating your eligibility for financial, business or health and safety grants.

### **4. How long will we keep your information?**

Welsh Government will only retain your personal data for 4 years and for the purposes set out in this document

After this point the collated data will either be deleted or anonymised in line with best practices and used only for statistical and research purposes.

### **5. Your rights in relation to your information.**

Under the data protection legislation, you have the right:

- to access the personal data the Welsh Government holds on you
- require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing
- for (in certain circumstances) your data to be 'erased'
- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
