Information redacted has asked me to prioritise the designation of the Marconi transmitter station as a matter of urgency and I am hoping you might be able to assist? Attached is the report Information redacted produced back in 2016 where she has mapped out the key structures. In the first instance, do you think you could look into land ownership please? Information redacted is already looking at the potential listings and has made a visit. I don't really know the site at all but it certainly seems like all of the relict structures – concrete blocks etc – would meet the criteria for scheduling. Let me know if there are complications with land ownership and if you could prepare a rough polygon pending field survey that would be very useful. I haven't given it a SM number yet or created an iShare folder or prepared any other designation stuff but will do this week. I'll send you a link once I've started things off...

GAT made scheduling and listing recommendations back in 2016 as part of the *First World War military sites: Manufacturing, research & development* project. I've just had a quick read through the reports associated with this project and the site appears to comprise a number of dispersed concrete bases, supports and stays associated with the radio antenna, an interconnecting light railway and a small number of brick-built ancillary and defensive structures. I would suggest that this group does meet the criteria for statutory protection and should be proposed for scheduling. The salient points are detailed in the confidential Part II report attached here. Is the site under threat in some way? I could look to prioritise this one if there is some urgency...
