## 2. OVERVIEW OF THE IMPLEMENTATION OF THE OPERATIONAL PROGRAMME (ARTICLE 50(2) AND 111(3)(A) OF REGULATION (EU) NO 1303/2013)

### 2.1. Key information on the implementation of the operational programme for the year concerned, including on financial instruments, with relation to the financial and indicator data.

In 2022 the circumstances in which the Programme operated became progressively more normal, following two years of severe disruptions in 2020 and 2021 due to the Covid-19 pandemic. Some aspects of changes made by operations to respond to the pandemic have proved to be more enduring, such as online and remote delivery of support to participants where this is appropriate. However, many types of employability support and work-focussed training are more suitably delivered face-to-face and operations have returned to this as public health concerns eased.

Progress on the implementation of the Programme continued to be good. By the end of December 2022, approvals issued by the Managing Authority amounted to a total commitment of £545m of eligible costs, supported by £180m of ESF Grant. At the Managing Authority's planning rate, which was maintained during the year at €1.17/£1, this meant that around 102% of the EU funds available under the Programme had been committed. The Managing Authority assesses this level of overcommitment as manageable, as some underspend by approved operations is expected as they reach their end-dates.

Eligible expenditure declared to the Managing Authority by beneficiaries up to December 2022 was £378m, around 99% of the Programme total. Funds paid out by WEFO to beneficiaries totalled £119m, around 67% of the total ESF available in the Programme.

The number of approved operations at the end of December 2022 was 46. Four of these operations had fully completed the Managing Authority's process for closure of operations and a further eight had reached the end-dates for their funding and were in the closure process.

In March 2022, following the outbreak of the war in Ukraine, the Managing Authority updated its participant eligibility guidance to include additional guidance on the eligibility of Ukrainian nationals in Wales to access support.

A funding approval was issued during the year for a retrospective operation in the new Priority 6 (Covid-19), which was introduced into the Programme using the flexibilities under the Coronavirus Response Investment Initiative (CRII). The operation was led by the Welsh Government's Health Department with local health boards and trusts from across East Wales as joint beneficiaries and has been offered £30m ESF towards total costs of £70m. The operation is expected to have supported the employment of almost 1,400 additional health and social care staff during the Coronavirus response as well as the purchase of some 134 million items of PPE.

The Managing Authority now considers all Priorities to be complete with no further operations expected to be approved. During 2022 some extensions in time were agreed for some operations, where suitably justified, to allow operations to recoup some of the activity lost due to Covid-19 restrictions and maximise the value of their interventions following the easing of restrictions.

The labour market in Wales during the year remained strong by historical standards, with an employment rate of around 72% and an unemployment rate below 4%. Nevertheless, there were well documented and long-standing disparities between different groups of workers and job-seekers. Against this backdrop, the approved ESF operations with their focus on supporting those furthest from the labour market; supporting upskilling in the workforce and helping young people to integrate into the labour market, remained relevant to the situation in Wales.

By December 2022, operations in the EW Programme had reported engaging with almost 97,000 participants and of these almost 46,000 had gained a qualification, 9,000 had been supported into employment or self-employment, and 3,000 young people had moved into education or training.

All 2022 N+3 targets were met.

The Managing Authority remained compliant with E-cohesion requirements. Electronic transfer of data between beneficiaries and the Managing Authority was supported by the externally facing system known as WEFO Online, used by beneficiaries to enter data, including everything from appraisal documentation to transaction lists and claims. This system links to the IT system used by Managing Authority and Certifying Authority Officials to manage structural funds, which is known as PPIMS.

#### 3. IMPLEMENTATION OF THE PRIORITY AXIS (ARTICLE 50(2) OF REGULATION (EU) NO 1303/2013)

#### ID Priority axis Key information on the implementation of the priority axis with reference to key developments, significant problems and steps taken to address these problems At the end of 2022, 103% of the ESF allocation had been committed to 9 operations. Tackling Poverty through 1 Sustainable Employment In total, almost 16,000 participants had been supported in this Priority by December 2022. Output indicators showed particularly high levels of participation by long-term unemployed participants. For this participant group the indicator target value set for 2023 had been significantly exceeded by the end of 2022. Good progress had also been made in supporting economically inactive participants, with 71% of the target value set for 2023 already achieved by the end of 2022. Results indicators presented a more mixed picture but showed that participants were achieving a range of positive outcomes relevant to their employment journeys. A particular strong point was the proportion of economically inactive participants entering employment which stood at 27%, above the target value of 20%. Lower numbers have been seen for some of the other results indicators for economically inactive and long-term unemployed participants, reflecting in part that operations have focussed on securing employment outcomes more than some intermediate steps such as work experience. Skills for Growth By the end of 2022, 112% of the EU funds available had been committed to 15 operations and over 54,000 participants had 2 been supported in this Priority. Output indicators showed high levels of participation by workers with an upper secondary education, with the indicator target values set for 2023 already been significantly exceeded by the end of 2022. The 2023 targets for male and female participants with lower secondary education in SO1 were also fully met by the end of 2022. There was also good progress against the targets for male and female participants with a graduate degree in SO3 (78% and 91% of the 2023 targets already achieved) and participants in SO4 (96% of the 2023 target already achieved). Progress was slower for participants with a lower secondary education in SO2, with 72% and 65% of the 2023 target values for males and females in this group achieved by the end of 2022. Results indicators were generally progressing satisfactorily, with the proportions of participants gaining qualifications tracking close to the target values across most participant groups. Qualifications and employment outcomes for postgraduate students ('participants with a graduate degree or equivalent') remain below target but this is reflective of data lags due to the long duration of post-graduate courses and these gaps are expected to narrow by the end of the Programme.

#### 4. SYNTHESIS OF THE EVALUATIONS

Synthesis of the findings of all evaluations of the programme that have become available during the previous financial year, with reference of name and reference period of the evaluation reports used

The WCVA Active Inclusion Fund Evaluation Final Report was published in September 2022.

Wales Council for Voluntary Action (WCVA) delivered Active Inclusion Fund (AIF) which was launched in 2015. AIF was created to contribute to addressing longstanding challenges in helping 'hard to reach' people in Wales engage or re-engage in the labour market. It provided grants for projects that helped disadvantaged people get back into employment or develop the skills to become more employable and improve their wellbeing. Most of all it helped people with a wide range of needs and backgrounds.

#### Key findings were:

- AIF supported over 23,000 individuals since 2015, with most participants consistently reporting positive experiences and benefits
- The programme successfully worked with many people in challenging circumstances with an impressive track record for participant outcomes in wellbeing and employment
- The flexibility of WCVA and AIF was widely appreciated by beneficiary organisations in helping them meet sometimes challenging European funding requirements
- AIF was surprisingly flexible and resilient to the effects of the Covid-19 pandemic, especially given the vulnerability of some people supported by the scheme
- This adaptability allowed beneficiary organisations to be more innovative, and not only support participants into work, but also support local businesses by growing their workforce
- Often these businesses (and participants) fell outside the typical opportunities for support with other more mainstream employability programmes
- AIF recognised that helping to improve things like wellbeing, confidence and resilience are vital for moving into employment as well as into healthier and more fulfilling lifestyles
- The evaluators calculated that in terms of 'social return on investment' for every £1 spent AIF generated approximately £3.37 of benefit
- AIF was important in building and enhancing voluntary sector capacity and expertise in delivering employability programmes.

AIF funded support for individuals and groups in or outside the most deprived areas. This wide 'reach' enabled support for people who might otherwise fall through the net.

#### 6 ISSUES AFFECTING THE PERFORMANCE OF THE PROGRAMME AND MEASURES TAKEN (Article 50(2) of Regulation (EU) No 1303/2013)

(a) Issues which affect the performance of the programme and the measures taken

In 2022 the circumstances in which the Programme operated became progressively more normal, following two years of severe disruptions in 2020 and 2021 due to the Covid-19 pandemic. The Managing Authority had worked closely with operations to provide flexibility where appropriate during the public health restrictions and continued to support operations to adapt as conditions improved in 2022. This included agreeing some extensions in time for some operations, where suitably justified, to allow operations to recoup some of the activity lost due to Covid-19 restrictions and maximise the value of their interventions following the easing of restrictions.

The rise in the cost of living during 2022 led to some operations needing to revisit some aspects of their expenditure. This applied particularly to student bursaries and training allowances/training wages for participants, where the amounts set before the rise in inflation were assessed as no longer sufficient to support participants adequately in the higher inflation environment. The Managing Authority worked with several affected operations to agree reasonable and benchmarked increases to previously agreed rates and consequent amendment of project budgets.

2022 was the third year of the programme in which the UK was no longer an EU member state. The Managing Authority continued to apply all relevant EU legislation in its management of the Programme and to require this of all operations. In practice this meant that beneficiaries experienced continuity of their funding regime. The Managing Authority identified a small number of issues with some possible impact on operations (for example, the need to be cognisant of the UK's new subsidy control regime whilst continuing to operate within the EU's state aid rules) and had guidance in place on these. Overall however, the continued application of EU regulations to the Programme, as provided for in the Withdrawal Agreement, meant that beneficiaries experienced little or no change or disruption to their operations.

(b) An assessment of whether progress made towards targets is sufficient to ensure their fulfilment, indicating any remedial actions taken or planned, where appropriate.

As noted in earlier sections of this report, a number of the targets set in the Programme for 2023 had already been met or exceeded by the end of 2022 and many others were showing continued good progress towards achieving the target values.

The following output targets for 2023 have already been met or exceeded by the end of 2022:

- Long term unemployed participants in Priority 1
- Employed participants with up to a lower secondary education in Priority 2
- Employed participants with upper secondary education in Priority 2
- Number of entities in Priority 5
- Number of projects in Priority 5

In 2022 the Managing Authority received an independent review of the performance of all its ESF, ERDF and ETC programmes against indicators, including the impact Covid-19 had had on progress. This report highlighted that there were likely to be shortfalls against some targets at the end of the Programme. The Managing Authority further reviewed the position and concluded that taken in the round the achievement across the EW ESF Programme is good and that, while there may be some underachievement against some targets, this will be balanced by overachievement against targets in some other areas. Given the unavoidable impact that the Covid-19 pandemic and other factors have had on this programme, the MA concluded that there was little to be gained from seeking to amend any targets as this would not assist programme implementation or serve any real purpose.
