However, please note that the Commissioner will not normally investigate a complaint until it has been through our own internal review process.

The request you sent me contains personal information about you - for example, your name and email address. We will only use this personal information to deal with your request and any matters which arise as a result of it. Your personal information will then be disposed of securely.

- to require us to rectify inaccuracies in that data
- to (in certain circumstances) object to or restrict processing

- to lodge a complaint with the Information Commissioner's Office (ICO) who is our independent regulator for data protection
