Mae Gweinidogion Cymru, sef yr awdurdod traffig ar gyfer cefnffordd yr A4060, wedi eu bodloni y dylid cyfyngu ar draffig ar ddarnau penodedig o'r gefnffordd oherwydd gwaith y bwriedir ei wneud ar y ffordd neu gerllaw iddi.

The Welsh Ministers, as traffic authority for the A4060 trunk road, are satisfied that traffic on specified lengths of the trunk road should be restricted because of works proposed on or near the road.

Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 14(1), (4) a (7) o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1), yn gwneud y Gorchymyn hwn.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 14(1), (4) and (7) of the Road Traffic Regulation Act 1984(1), make this Order.

### Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A4060 (Cylchfan Fach Dowlais i Gylchfan Abercannaid, Merthyr Tudful) (Terfynau Cyflymder Dros Dro) 2023 a daw'r Gorchymyn hwn i rym ar 1 Ionawr 2024.

### Title and commencement

1. The title of this Order is the A4060 Trunk Road (Little Dowlais Roundabout to Abercannaid Roundabout, Merthyr Tydfil) (Temporary Speed Limits) Order 2023 and this Order comes into force on 1 January 2024.

### Dehongli

### Interpretation

2. In this Order—

"exempted vehicle" ("*cerbyd esempt*") means—

Yn rhinwedd O.S. 1999/672, ac adran 162 o Ddeddf Llywodraeth Cymru 2006 (p. 32) a pharagraff 30 o Atodlen 11 iddi, mae'r pwerau hyn yn arferadwy bellach gan Weinidogion Cymru o ran Cymru.

(1) 1984 c. 27; section 14 was substituted by the Road Traffic (Temporary Restrictions) Act 1991 (c. 26), section 1(1) and Schedule 1. By virtue of S.I. 1999/672, and section 162 of, and paragraph 30 of Schedule 11 to, the Government of Wales Act 2006 (c. 32), these powers are now exercisable by the Welsh Ministers in relation to Wales.

- (a) unrhyw gerbyd sy'n cael ei ddefnyddio gan y gwasanaethau brys at y dibenion a ddisgrifir yn adran 87 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984(1) neu mewn cysylltiad â'r gwaith sy'n arwain at y Gorchymyn hwn;
- (b) unrhyw gerbyd sy'n cael ei ddefnyddio at ddibenion y llynges, y fyddin neu'r llu awyr ac sy'n cael ei yrru gan berson sydd am y tro yn ddarostyngedig i orchmynion aelod o luoedd arfog y Goron, sy'n aelod o'r lluoedd arbennig—
- (i) ac sydd wedi ei hyfforddi i yrru ar gyflymderau uchel ac sy'n gweithredu wrth ymateb, neu wrth ymarfer ymateb, i argyfwng diogelwch gwladol, neu
- (ii) at ddiben hyfforddi person i yrru cerbydau ar gyflymderau uchel;

ystyr “cyfnod y gwaith” (“*works period*”) yw cyfnodau ysbeidiol sy'n dechrau am 06:00 o'r gloch ar 1 Ionawr 2024 ac sy'n dod i ben pan gaiff yr arwyddion traffig dros dro ar gyfer pob cyfnod gwaith eu symud ymaith;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A4060 Man i'r Dwyrain o Abercynon i Fan i'r Dwyrain o Ddowlais;

ystyr “lluoedd arbennig” (“*special forces*”) yw'r unedau hynny o'r lluoedd arfog y mae Cyfarwyddwr y Lluoedd Arbennig yn gyfrifol am gynnal eu galluoedd neu sydd am y tro yn ddarostyngedig i reolaeth weithredol y Cyfarwyddwr hwnnw.

## Cyfyngiadau

**3.** Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 50 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Hysbysiad hwn.

**4.** Ni chaiff neb, yn ystod cyfnod y gwaith, yrru unrhyw gerbyd modur yn gyflymach na 40 milltir yr awr ar y darnau o'r gefnffordd a bennir yn yr Atodlen i'r Hysbysiad hwn.

- (a) any vehicle being used by the emergency services for the purposes described in section 87 of the Road Traffic Regulation Act 1984(1) or in connection with the works giving rise to this Order;
- (b) any vehicle being used for naval, military or air force purposes and being driven by a person for the time being subject to the orders of a member of the armed forces of the Crown, who is a member of the special forces—
- (i) in response, or for practice in responding, to a national security emergency by a person who has been trained in driving at high speeds, or
- (ii) for the purpose of training a person in driving vehicles at high speeds;

“special forces” (“*lluoedd arbennig*”) means those units of the armed forces the maintenance of whose capabilities is the responsibility of the Director of Special Forces or which are for the time being subject to the operational command of that Director;

“the trunk road” (“*y gefnffordd*”) means the A4060 East of Abercynon to East of Dowlais trunk road;

“works period” (“*cyfnod y gwaith*”) means intermittent periods commencing at 06:00 hours on 1 January 2024 and ending when the temporary traffic signs for each period of works are removed.

## Restrictions

**3.** No person may, during the works period, drive any motor vehicle at a speed exceeding 50 miles per hour on the lengths of the trunk road specified in the Schedule to this Notice.

**4.** No person may, during the works period, drive any motor vehicle at a speed exceeding 40 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

### **Atal Dros Dro**

6. Mae unrhyw ddarpariaethau statudol sy'n cyfyngu ar gyflymder cerbydau ar y darnau o'r gefnffordd wedi eu hatal dros dro ar yr adegau hynny pan fo'r cyfyngiadau a bennir yn erthyglau 3, 4 a 5 yn weithredol.

### **Cymhwyso**

7.—(1) Nid yw'r cyfyngiadau yn erthyglau 3, 4 a 5 yn gymwys ond ar yr adegau hynny ac i'r graddau hynny y bydd arwyddion traffig yn eu dangos.

(2) Nid yw unrhyw terfynau cyflymder a osodir gan y Gorchymyn hwn yn gymwys i gerbyd esempt.

### **Cyfnod Para'r Gorchymyn hwn**

8. Bydd y Gorchymyn hwn yn para am 18 mis ar y mwyaf.

### **YR ATODLEN**

Y darnau o gerbyttffordd tua'r gogledd a cherbyttffordd tua'r de y gefnffordd sy'n ymestyn o gerbyttffordd gylchredol gyfan Cylchfan Fach Dowlais ac yn ei chynnwys hyd at gerbyttffordd gylchredol gyfan Cylchfan Abercannaid ac yn ei chynnwys.

Y darnau cyfan o ffyrdd ymadael/ymuno tua'r gogledd a ffyrdd ymadael/ymuno tua'r de y gefnffordd rhwng Cylchfan Fach Dowlais a Chylchfan Abercannaid.

5. No person may, during the works period, drive any motor vehicle at a speed exceeding 30 miles per hour on the lengths of the trunk road specified in the Schedule to this Order.

### **Suspension**

6. Any statutory provisions restricting the speed of vehicles on the lengths of the trunk road are suspended during such times as the restrictions specified in articles 3, 4 and 5 are in operation.

### **Application**

7.—(1) The restrictions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

(2) No speed limits imposed by this Order apply to an exempted vehicle.

### **Duration of this Order**

8. The maximum duration of this Order is 18 months.

### **SCHEDULE**

The lengths of the northbound and southbound carriageways of the trunk road that extend from and include the entire circulatory carriageway of Little Dowlais Roundabout to and include the entire circulatory carriageway of Abercannaid Roundabout.

The entire lengths of the northbound and southbound exit/entry slip roads of the trunk road between Little Dowlais Roundabout and Abercannaid Roundabout.
