## **Provisional Police Settlement 2024-25**

Following the announcement today by the Home Office of its Provisional Settlement for Policing in England and Wales, I am writing to provide details of the Welsh Government's component of the Provisional Police Settlement for police forces in Wales for 2024-25.

The Home Office announcement set out that taking together the Home Office and Welsh Government components, all Welsh police forces will receive an increase of 2.054% in core funding in 2024-25.

**Annex A** contains details of the Provisional Settlement for each police force in Wales.

The period of formal consultation on the amount and distribution begins today and closes on 10 January 2024. Responses should be sent to:

## Notes:

- 1.Following the 2015 Comprehensive Spending Review, the Home Office made an annual transfer of funding to the Welsh Government in order for the Welsh Government to deliver its agreed contribution to police funding in Wales. From 2022-23 onwards, this additional funding is no longer transferred and is instead delivered by the Home Office through the Police Grant and Top Up Grant. This resulted in the Welsh Government contribution to policing reducing by £29.93m in 2022-23 and subsequent years. This is purely an administrative change and does not result in any change in overall funding for any Police Force.
- 2. This is the amount of police grant set out in section 3 of the Police Grant Report which includes the allocation under 'Principal Formula' and 'Add Rule 1' (columns a and b) plus the amount 'floor funding' that the Home Office has made available.
- 3. Figures for 2024-25 are shown before the adjustment made for the transfer of Special Branch funding, as outlined in paragraph 4.8 of the Police Grant Report.
- 4. Figures for 2023-24 have been restated to include the in-year funding awarded to forces for the 2023-24 pay deal.
