

**GORCHYMYN CEFNFFORDD YR A40  
(PONTARGOTHI, SIR GAERFYRDDIN)  
(GWAHARDD CERBYDAU DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A40 ar Bont Pontargothi ym Mhontargothi, Sir Gaerfyrddin.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd, ac eithrio'r rhai a ddefnyddir gan y gwasanaethau brys ac ar gyfer y gwaith, rhag mynd ar y darn o gefnffordd yr A40 sy'n ymestyn o bwynt 45 o fetrau i'r gorllewin o'r gyffordd â Chwrt y Cresselly hyd at bwynt 60 metr i'r dwyrain o'r gyffordd â Thŷ Newydd ym Mhontargothi.

Y llwybr arall ar gyfer cerbydau sy'n teithio tua'r dwyrain fydd mynd ar yr A40 tua'r gorllewin i Gylchfan Glangwili, yr A40 tua'r de-orllewin i Gylchfan Pensarn, yr A48 tua'r de-ddwyrain i Gylchfan Cross Hands, yr A476 tua'r gogledd-ddwyrain i Ffair-fach a'r A483 tua'r gogledd drwy Landeilo i ailymuno â'r A40. I'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gorllewin.

Disgwylir y bydd y gwaharddiad, y codir arwyddion priodol yn ei gylch, yn weithredol o 10:00 o'r gloch hyd 13:00 o'r gloch ar 26 Ionawr 2024 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod yr dyddiadau a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad ymlaen llaw am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A40 TRUNK ROAD (PONTARGOTHI,  
CARMARTHENSHIRE) (TEMPORARY  
PROHIBITION OF VEHICLES) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984 which is necessary to undertake works on the A40 trunk road on Pontargothi Bridge at Pontargothi, in the County of Carmarthenshire.

The effect of the Order is to temporarily prohibit all vehicles, other than those being used by the emergency services and for the works, from proceeding on the length of the A40 trunk road that extends from a point 45 metres west of the junction with Cwrt y Cresselly to a point 60 metres east of the junction with Ty Newydd House at Pontargothi.

The alternative route for eastbound vehicles will be via the westbound A40 to Glangwili Roundabout, south-westbound A40 to Pensarn Roundabout, south-eastbound A48 to Cross Hands Roundabout, north-eastbound A476 to Fair-fach and northbound A483 through Llandeilo to re-join the A40. Vice versa for westbound vehicles.

It is expected that the prohibition, which will be signed accordingly, will operate from 10:00 hours until 13:00 hours on 26 January 2024 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the times and dates specified above it will remain valid for a maximum period of 18 months as a contingency should the work need to be rescheduled or consequential or other work is required. Advance notice of any changes to times and dates will be displayed before any rescheduled work.
