Thank you for your email received on 20 December 2023 which was dealt with under the Freedom of Information Act (2000). You have requested the following:

For the year 2022/2023 per child/annum and per adult/annum in Education/Social Services/Health services

- 1. Provide figures for spending on Children and Young People and adult mental health difficulties in Wales with a breakdown of each sector
- 2. Provide statistics for obesity rates, sedentary lifestyles and the associated costs
- 3. Provide figures of the cost of adult crime with a history of conduct disorder

## Our Response

1 Welsh Government does not hold the information at the level you are requesting on the cost of providing mental health services. We can provide details of the grants we give Local Authorities to support the whole school approach to mental health and wellbeing and this is published as part of our annual budget. A breakdown of spend per category for the NHS can be seen <u>here</u>

- 2 In relation to obesity rates in children and young people, Public Health Wales publish data on the <u>child measurement programme</u> for young children and the School health research network produce a <u>national report</u> which has self-reported BMI of older children as well as sedentary behaviour. For adults data on BMI is published in these reports and tables: <u>Adult lifestyle (National Survey for Wales) | GOV.WALES</u>
- 3 Criminal justice is not devolved to Wales and is the responsibility of the UK Government. On that basis, Welsh Government does not hold the information being requested on the cost of adult crime with a history of conduct disorder. The most recent official estimates from Home Office are for 2015/16 (published in 2018) and don't include breakdowns for Wales - <u>The economic and social costs of crime</u>.
