The Cockles and Mussels (Specified Areas) (Wales)
Order 2011

PERMIT TO TAKE COCKLES from the Area defined below for the period 1st September 2023 – 31st August 2024

THIS PERMIT entitles the Permit Holder

to fish for and take cockles from the area defined in the Schedule to this permit (“the Area”), subject to the Conditions set out below.

CONDITIONS:

1. Only the Permit Holder may fish for and take any cockles from the Area. The Permit Holder may not be assisted by any other person and this Permit cannot be transferred to any other person.
2. The Permit Holder may only fish for and take any cockles from any fishery within the Area which is not subject to a closure pursuant to Byelaws 13A, 14 and/or 16 of the former North Western and North Wales Sea Fisheries Committee¹ or otherwise.
3. This Permit is valid from 00:01 on 1st September 2023 until 23:59 on 31st August 2024. This Permit expires automatically, if not terminated or withdrawn before that date.
4. The permit holder must always keep Section B with them and be prepared to show it to a Welsh Government Officer or any Marine Enforcement Officer on demand.
5. The Permit Holder must make a full and true report (“catch return”) of cockles taken from the Area to the Marine and Fisheries Division, Welsh Government, Suite 3, Cedar Court, Haven’s Head Business Park, Milford Haven, Pembrokeshire SA73 3LS, Email: MilfordHavenFisheriesOffice@gov.wales not later than the 5th day of the calendar month following the month in which those cockles were taken. The catch return must specify the date, location and quantities (in kilogrammes) of live weight of cockles that were taken from the Area during the specified month. If appropriate the catch return must specify that no cockles were taken. Link to catch return: <https://gov.wales/north-wales-cockle-and-mussel-catch-return>
6. The Permit Holder must comply with all demands and instructions issued by any Welsh Government’s Fisheries Enforcement Officer and/or any Marine Enforcement Officer.
7. **No person shall fish for, take or remove cockles between half an hour after sunset on any day and half an hour before sunrise on the following day.**

¹ The byelaws of the former North Western and North Wales Sea Fisheries Committee now have effect, to the extent that they could have been made by the Welsh Ministers in a Statutory Instrument, as if they were made by the Welsh Ministers in a Statutory Instrument – see Article 13(3) of and Schedule 4 to the Marine and Coastal Access Act 2009 (Commencement No. 1, Consequential, Transitional and Savings Provisions) (England and Wales) Order 2010 (S.I. 2010/630 (c.42)).



8. **Traeth Lafan** – The Permit Holder **must** access the fishery and land and remove cockles from the fishery through the Aber Ogwen car park situated adjacent to **Point A** in the Schedule definition of this area.
9. In addition, the Permit Holder **must** access the fishery along the access route shown on the map entitled “Traeth Lafan Access Map” at **Annex 3**.
10. The Permit Holder **must** not enter the two areas marked “Keep Out” on the map entitled “Traeth Lafan Access Map” at **Annex 3**.
11. **Gathering to take place on Fridays, Saturdays, Mondays and Thursdays ONLY.**
12. **Traeth Melynog** - The Permit Holder **must** only access the fishery and land and remove cockles from the fishery at **Point C** in the Schedule to this Permit. **Gathering to take place on Tuesdays and Wednesdays ONLY.**
13. In addition, the Permit Holder **must** only access the fishery along the route marked “Access” on the map titled “Traeth Melynog Access Map” at **Annex 6**.
14. The Permit Holder **must not** cause, allow or permit any vehicle to enter the area marked in green on the map at **Annex 4**. The permit Holder **must not** cause, allow or permit any vehicle to enter beyond any point marked with a Natural Resources Wales prohibition notice.
15. The Permit Holder **must not** cause, allow or permit any cockle gathering activity to be undertaken in a way which could affect any Dwarf eelgrass (*Zostera noltei*). A map showing known locations of Dwarf eelgrass (*Zostera noltei*) is attached at **Annex 5**. This map provides a number of defined areas in which gathering activity is **prohibited**.
16. **Gathering to take place on Tuesdays and Wednesdays ONLY.**
17. **Red Wharf Bay – will remain closed.**
18. **Termination:** The Welsh Ministers may, in their absolute discretion, withdraw this Permit at any time. Where possible prior notice of withdrawal will be given, but in any of the following circumstances, this Permit may be withdrawn immediately (i.e. without prior notice)-
 - a. in the case of emergency;
 - b. if the Permit Holder breaches any of the conditions of this Permit;
 - c. if it should transpire that the activities authorised by this Permit will result or are likely to result in a significant effect to any European Marine Site (as defined by Regulation 8(4) of the Conservation of Habitats and Species Regulations 2010 (S.I. 2010/490).
19. Breach of any of the conditions of this Permit is a criminal offence and will result in the immediate termination of this Permit.

Any person who contravenes the terms and conditions of this Permit is guilty of an offence under section 190 of the Marine and Coastal Access Act 2009. A person found guilty of an offence under that section is liable on summary conviction to a fine not exceeding £50,000. In addition, the Court may order the forfeiture of any fishing gear used in the offence and any sea fisheries resources in respect of which the offence was committed or a sum of money representing the value of that fishing gear or resources. The Court may also suspend the Permit or disqualify the individual from holding such a Permit for such period as the Court thinks fit.

This Permit is issued under authority of the Minister for Rural Affairs and North Wales, and Trefnydd, one of the Welsh Ministers pursuant to Article 6(1) of the Cockles and Mussels (Specified Area) (Wales) Order 2011 (S.I. 2011/1988 (W.219)).

Please note:

1. This Permit is issued pursuant to Article 6 of the Cockles and Mussels (Specified Area) (Wales) Order 2011 (S.I. 2011/1988 (W.219)) and relates only to that Statutory Instrument.
2. The Permit Holder must comply with all other applicable legislation (including the Byelaws of the former North Western and North Wales Sea Fisheries Committee and other applicable legislation (including fisheries and environmental legislation)) and obtain any other necessary permissions and/or authorisations before fishing for and taking any cockles from the Area defined in the Schedule to this Permit.
3. The Permit does not authorise the use of vehicles on or otherwise grant access to land bordering the Area. This authorisation does not provide any defence to prosecution under any other legislation. It has no effect in relation to and will not provide a defence to any other legal provision or requirement, including any provision of the Road Traffic Act 1988 or any other legislation applying to the use of a vehicle.
4. In addition to other statutory provisions, you may be committing a criminal offence if you use a vehicle in the Area and bordering areas without first obtaining the prior permission of all relevant landowners (and any other relevant bodies) over whose land you intend to travel. You should also note that unless each relevant landowner has carried out all assessments required under any relevant nature conservation or environmental legislation (for example under the Habitats Directive (Council Directive 92/43/EEC)) before granting permission to use your vehicle in the specified area, you may still be committing a criminal offence even if you have the landowner's permission.
 - Permit holders should be aware that it is a legal requirement that each batch of cockles must be accompanied by a Registration Document (previously movement documents) when moved from the production area, i.e. the shellfish bed, or when first placed on the market. In accordance with Regulation (EC) No 853/2004, Registration Documents must be completed and include the gatherer's details, the bed from which the shellfish were gathered and the date, before the cockles are transported. These documents can be obtained from either Anglesey County Council (Traeth Melynog) or Gwynedd County Council (Traeth Lafan) using the following contact details:

5. Permit holders are also advised that, in order to utilise vehicles on Traeth Melynog, including All Terrain Vehicles/ Multi Purpose Vehicles / quad bikes, authorisation will be required from Natural Resources Wales and Anglesey County Council in accordance with their byelaws. 6. The Welsh Government has determined a Total Allowable Catch ("TAC") of Cockles from Traeth Lafan of **652 tonnes** and Traeth Melynog of **168 tonnes** for the 2023/2024 season.
7. When this TAC has been reached, the relevant area will be closed by the Welsh Government pursuant to Byelaw 13A and/or Byelaw 16 of the former North Western and North Wales Sea Fisheries Committee.
8. Similarly, if it should transpire that the activities authorised by this Permit will result or are likely to result in a significant effect to any European Marine Site (as defined by Regulation 8(4) of the Conservation of Habitats and Species Regulations 2010 (S.I. 2010/490) the Welsh Government will close the fishery.
9. Any closure of the Area to cockle fishing activity will be notified, in the first instance, by Welsh Government Enforcement Staff present at the site and by notices put up in that area. A letter will also be sent to each permit holder confirming the area which is closed and the relevant closure notice will be published on the Welsh Government website at: <https://gov.wales/intertidal-fisheries>
10. The hatched area shown on the plan at **Annex 2** illustrates, for information purposes only, the area at Traeth Melynog which is classified as a bivalve mollusc production area for the purposes of EU Regulation 854/2004.



Schedule

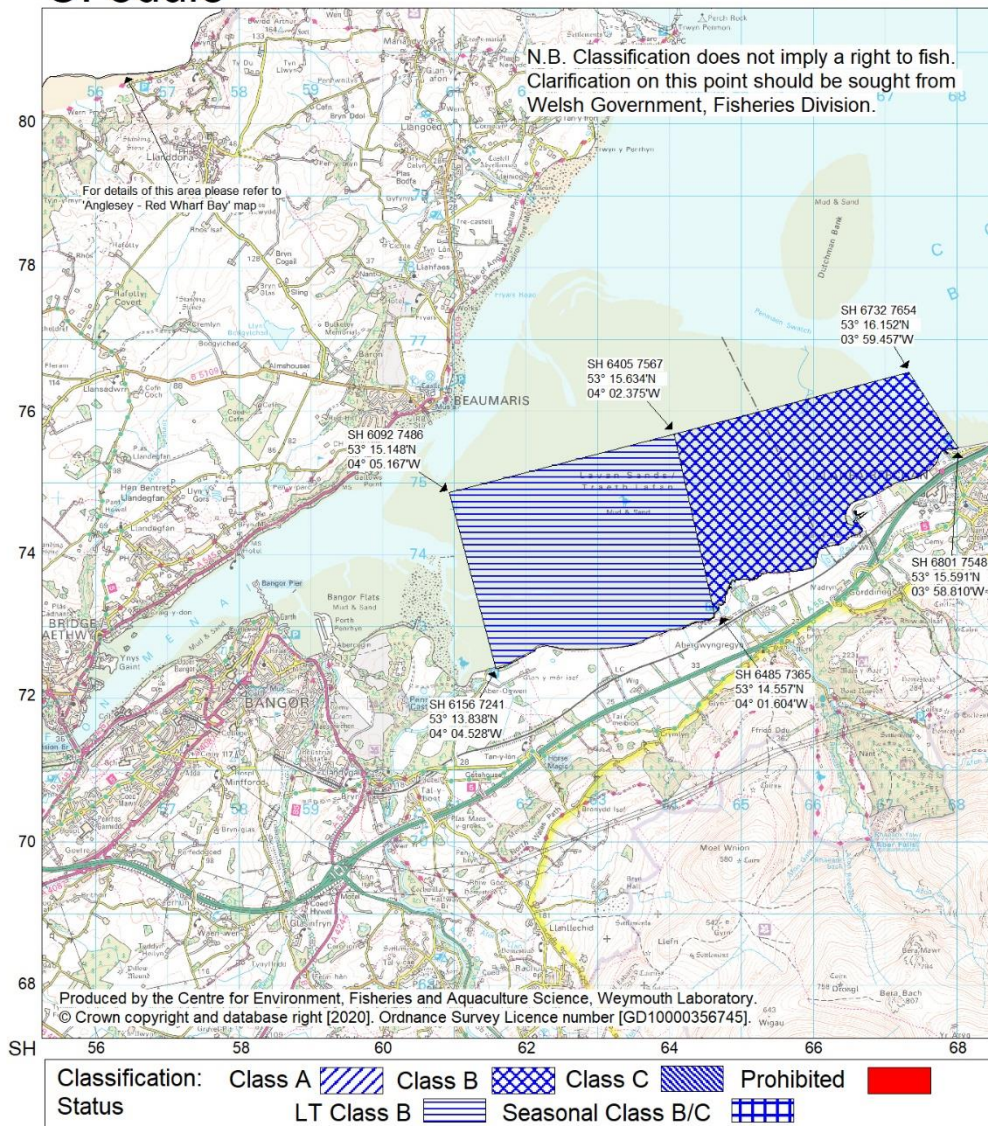

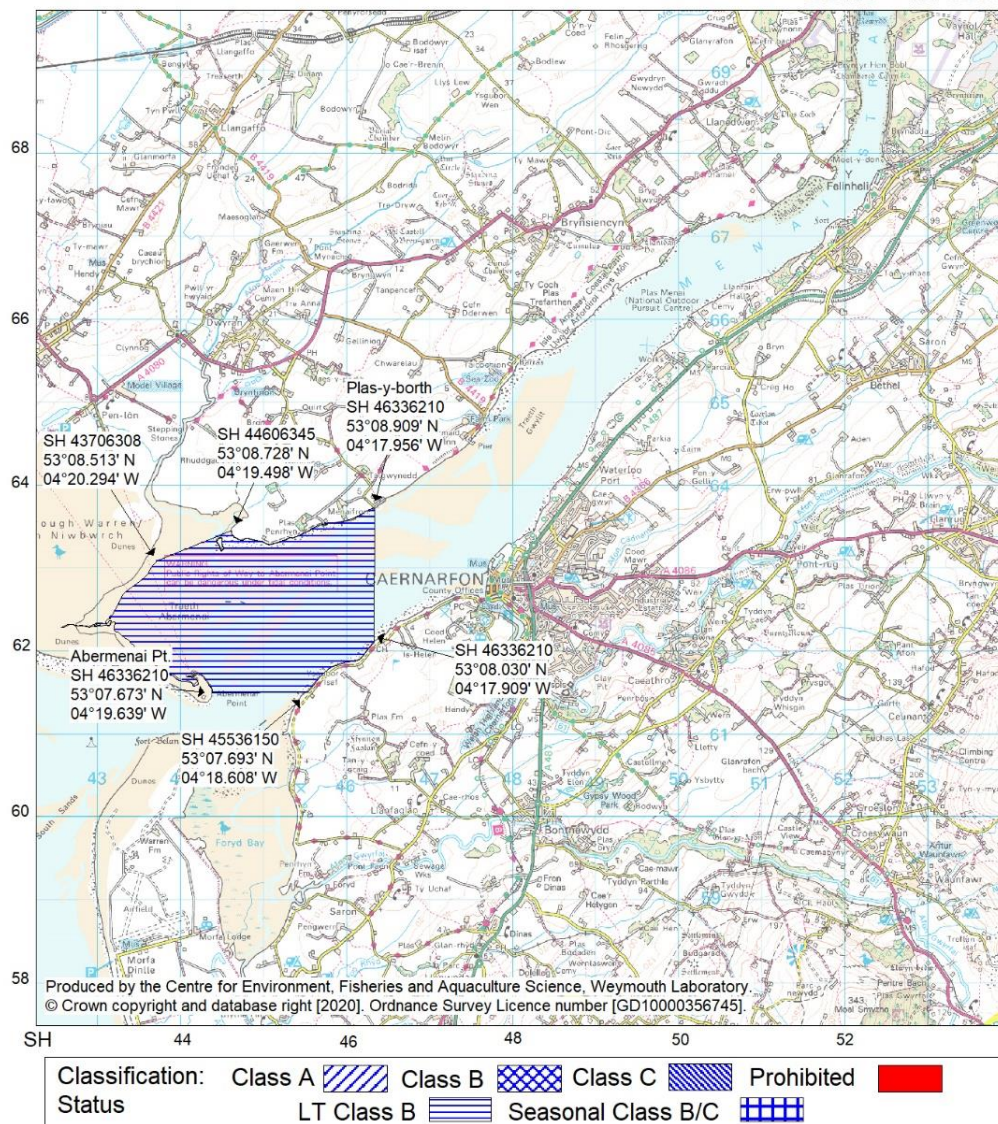

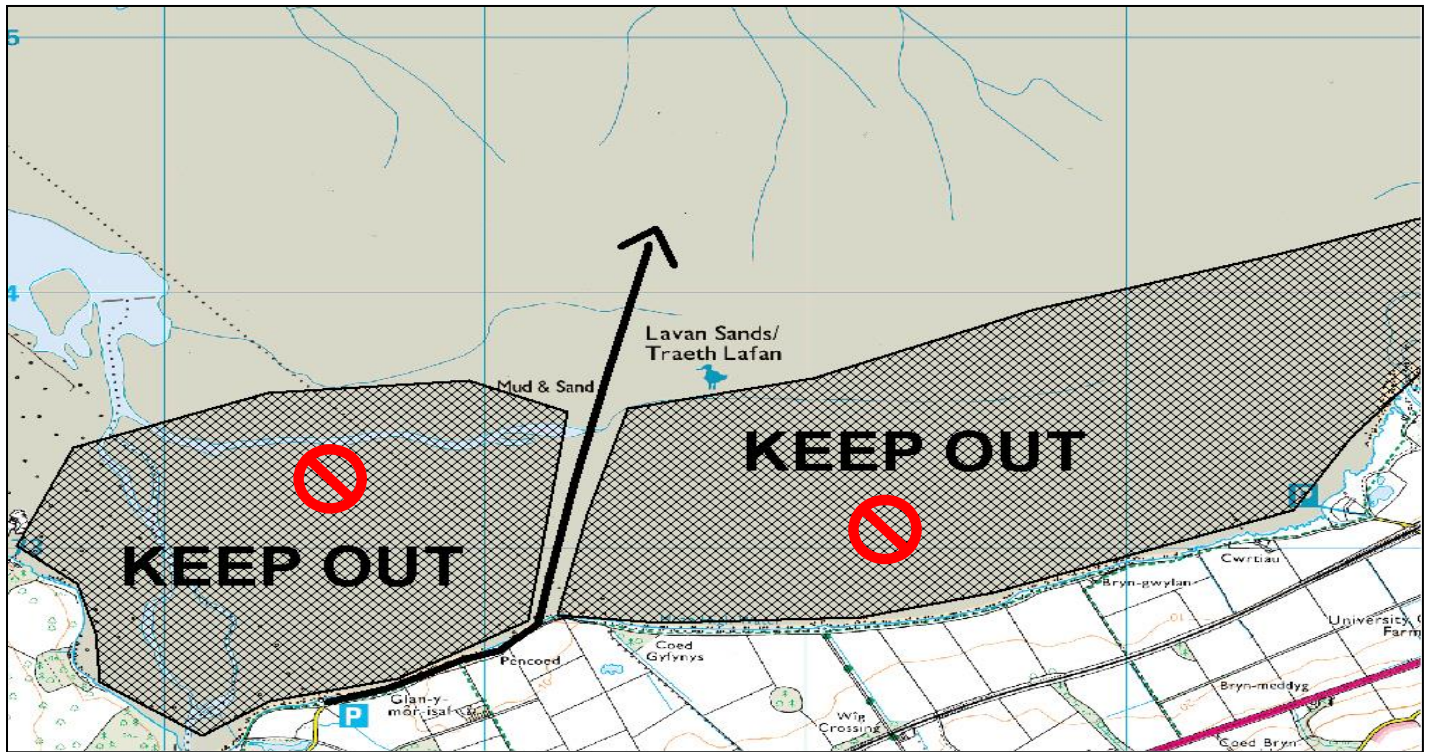

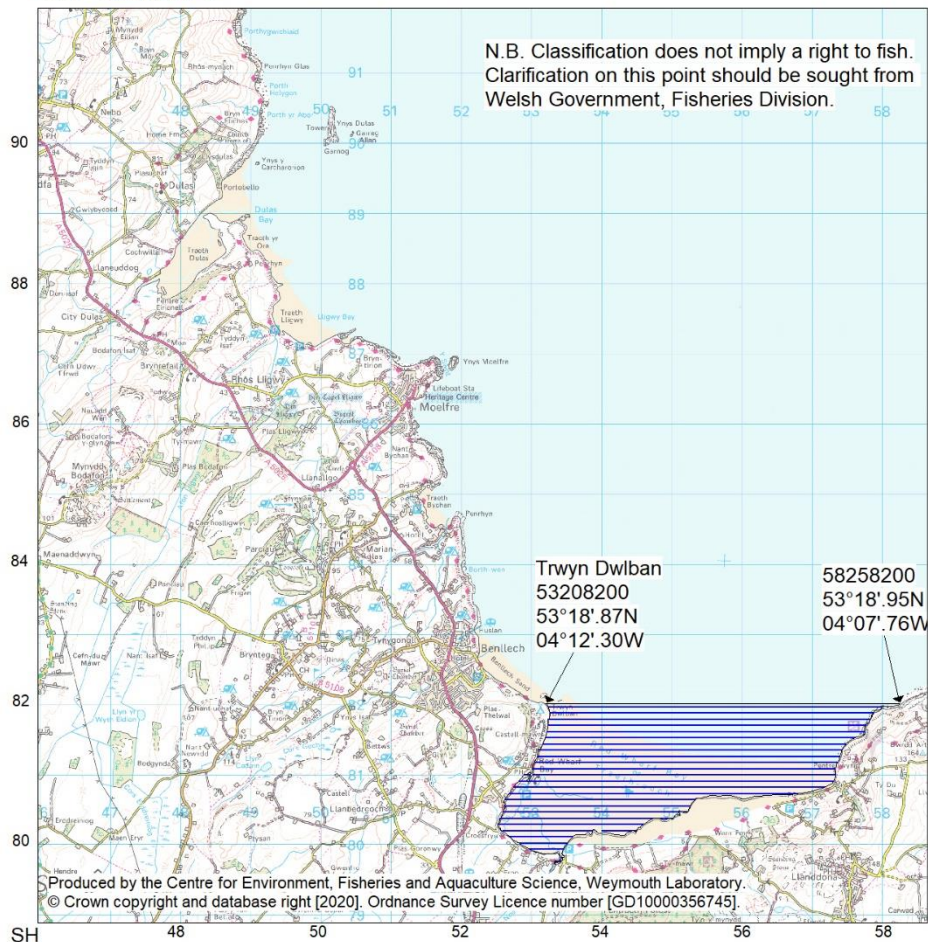
Traeth Melynog Access Map
