

**GORCHYMYN CEFNFFORDD YR A48 (MAN
I'R DWYRAIN O NANT-Y-CAWS, SIR
GAERFYRDDIN) (GWAHARDD TROI I'R DDE
DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A48, neu gerllaw iddi, mewn man i'r dwyrain o Nant-y-caws, Sir Gaerfyrddin.

Effaith y Gorchymyn yw gwahardd dros dro bob cerbyd rhag mynd ar hyd lôn troi i'r dde tua'r dwyrain neilltuedig yr A48 i mewn i'r ganolfan ailgylchu a'r safle tirlenwi i'r dwyrain o Nant-y-caws, Sir Gaerfyrddin.

Y llwybr arall fydd mynd ar hyd yr A48 tua'r dwyrain i Gylchfan Cross Hands a dychwelyd tua'r gorllewin.

Daw'r Gorchymyn i rym ar 2 Mawrth 2024. Disgwylir y bydd y gwaharddiad dros dro yn weithredol rhwng 20:00 o'r gloch ar 2 Mawrth a 06:00 o'r gloch ar 3 Mawrth 2024 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 12 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A48 TRUNK ROAD (EAST OF
NANTYCAWS, CARMARTHENSHIRE)
(TEMPORARY PROHIBITION OF RIGHT-
HAND TURN) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A48 trunk road to the east of Nantycaws, Carmarthenshire.

The effect of the Order is to temporarily prohibit all vehicles from proceeding in the A48 eastbound dedicated right-turn lane into the recycling centre and landfill site east of Nantycaws, Carmarthenshire.

The alternative route is via the eastbound A48 to Cross Hands Roundabout and return westbound.

The Order comes into force on 2 March 2024. The temporary prohibition is expected to operate from 20:00 hours on 2 March until 06:00 hours on 3 March 2024 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to operate during the period specified above, it will remain valid for a maximum period of 12 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
