

**GORCHYMYN CEFNFFORDD YR A483 (MAN
I'R GORLLEWIN O GILMERI, POWYS)
(GWAHARDD TRAFFIG DROS DRO) 2024**

Mae Gweinidogion Cymru wedi gwneud Gorchymyn o dan adran 14 o Ddeddf Rheoleiddio Traffig Ffyrdd 1984. Mae angen y Gorchymyn er mwyn gwneud gwaith ar gefnffordd yr A483, neu gerllaw iddi, ger Cilmeri, Powys.

Effaith y Gorchymyn yw gwahardd dros dro yr holl draffig (modur, difodur a cherddwyr) a da byw rhag mynd ar y darn o gefnffordd yr A483 i'r gorllewin o Gilmeri sy'n ymestyn o ganolbwynt ei chyffordd â'r ffordd fynediad sy'n arwain at Llanfechan House hyd at ganolbwynt ei chyffordd â'r ffordd fynediad sy'n arwain at Comyn Cottage. Sicrheir mynediad i eiddo lleol, pan fo'n bosibl.

Y llwybr arall ar gyfer traffig sy'n teithio tua'r dwyrain fydd mynd ar yr A483 tua'r de-orllewin i Lanymddyfri, yr A40 tua'r dwyrain i Aberhonddu a'r A470 tua'r gogledd i Lanfair-ym-Muallt i ailymuno â'r A483: i'r gwrthwyneb ar gyfer cerbydau sy'n teithio tua'r gorllewin.

Daw'r Gorchymyn i rym ar 4 Mawrth 2024. Disgwylir y bydd y gwaharddiadau dros dro yn weithredol yn ysbeidiol rhwng 19:00 o'r gloch ar 4 Mawrth a 07:00 o'r gloch ar 16 Mawrth 2024 neu hyd nes y caiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol.

Dim ond yn ystod y cyfnod a bennir uchod y disgwylir i'r Gorchymyn fod yn weithredol. Er hynny, bydd yn parhau'n ddilys am gyfnod o 18 mis ar y mwyaf rhag ofn y bydd angen ailamserlennu'r gwaith neu wneud gwaith canlyniadol neu waith arall. Bydd hysbysiad am unrhyw newidiadau i'r amseroedd a'r dyddiadau yn cael ei arddangos cyn gwneud unrhyw waith a ailamserlennir.

**THE A483 TRUNK ROAD (WEST OF
CILMERY, POWYS) (TEMPORARY
PROHIBITION OF TRAFFIC) ORDER 2024**

The Welsh Ministers have made an Order under section 14 of the Road Traffic Regulation Act 1984, which is necessary to undertake works on or near the A483 trunk road near Cilmeri, Powys.

The effect of the Order is to temporarily prohibit all traffic (motorised, non-motorised and pedestrians) and livestock from proceeding on the length of the A483 trunk road to the west of Cilmeri that extends from the centre-point of its junction with the access road leading to Llanfechan House to the centre-point of its junction with the access road leading to Comyn Cottage. Access will be maintained to local properties, where possible.

The alternative route for eastbound traffic is via the south-westbound A483 to Llandovery, eastbound A40 to Brecon and northbound A470 to Builth Wells to rejoin the A483: vice versa for westbound vehicles.

The Order comes into force on 4 March 2024. The temporary prohibitions are expected to operate intermittently from 19:00 hours on 4 March until 07:00 hours on 16 March 2024 or until the temporary traffic signs are permanently removed.

Although the Order is only expected to be in force during the period specified above it will remain valid for a maximum period of 18 months, as a contingency, should the work need to be rescheduled or consequential or other work is required. Notice of any changes to times and dates will be displayed before any rescheduled work begins.
