Mae Gweinidogion Cymru, felly, drwy arfer y pwerau a roddir iddynt gan adran 16A o Ddeddf Rheoleiddio Traffig Ffyrrd 1984(1), yn gwneud y Gorchymyn hwn.

Enwi a chychwyn

1. Enw'r Gorchymyn hwn yw Gorchymyn Cefnffordd yr A5 (Cylchfan Ffordd Caergybi, Bangor, Gwynedd i Gylchfan Ffordd Mona, Porthaethwy, Ynys Môn) (Gwahardd Cerbydau, Beicwyr a Cherddwyr Dros Dro) 2024 a daw'r Gorchymyn hwn i rym ar 3 Mawrth 2024.

The A5 Trunk Road (Holyhead Road Roundabout, Bangor, Gwynedd to Mona Road Roundabout, Menai Bridge, Anglesey) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2024

Made

26 February 2024

Coming into force

3 March 2024

The Welsh Ministers, as traffic authority for the relevant length of the A5 trunk road, are satisfied that traffic on a specified length of the trunk road should be prohibited by reason of a relevant event, namely the Anglesey Half Marathon and 10K Race, being held on or near the road.

The Welsh Ministers, therefore, in exercise of the powers conferred upon them by section 16A of the Road Traffic Regulation Act 1984(1), make this Order.

Title and commencement

1. The title of this Order is the A5 Trunk Road (Holyhead Road Roundabout, Bangor, Gwynedd to Mona Road Roundabout, Menai Bridge, Anglesey) (Temporary Prohibition of Vehicles, Cyclists & Pedestrians) Order 2024 and this Order comes into force on 3 March 2024.

Dehongli

2. Yn y Gorchymyn hwn—

ystyr “cerbyd esempt” (“*exempted vehicle*”) yw—

- (i) unrhyw gerbyd sy’n cael ei ddefnyddio at ddibenion yr heddlu, y gwasanaeth tân neu’r gwasanaeth ambiwlans;
- (ii) unrhyw gerbyd sy’n cael ei ddefnyddio mewn cysylltiad â gwaith ar y ffordd neu oleuadau neu arwyddion traffig neu waith brys i unrhyw garthffos neu i unrhyw brif bibell neu gyfarpar ar gyfer cyflenwi nwy, dŵr neu drydan, neu gyfarpar telathrebu yn y darn o’r ffordd o dan sylw, neu mewn unrhyw dir cyfagos;
- (iii) unrhyw gerbyd sy’n cael ei ddefnyddio gan un o swyddogion awdurdodedig y digwyddiad i gefnogi’r digwyddiad perthnasol ac am resymau diogelwch;

ystyr “cyfnod y digwyddiad” (“*event period*”) yw’r cyfnod hwnnw sy’n dechrau am 09:00 o’r gloch ar 3 Mawrth 2024 ac sy’n dod i ben pan gaiff yr arwyddion traffig dros dro eu symud ymaith yn barhaol;

ystyr “y gefnffordd” (“*the trunk road*”) yw cefnffordd yr A5 Llundain i Gaergybi sy’n ymestyn o’i chyffordd â Chylchfan Ffordd Caergybi (Tafarn yr Antelope), Bangor, Gwynedd hyd at ei chyffordd â Chylchfan Ffordd Mona (Garej Shell), Porthaethwy, Ynys Môn.

Gwaharddiad

3. Ni chaiff neb, yn ystod cyfnod y digwyddiad, yrru unrhyw gerbyd, ac eithrio cerbyd esempt, ar y darn o’r gefnffordd.

4. Ni chaiff neb, yn ystod cyfnod y digwyddiad, reidio unrhyw feic pedal ar y darn o’r gefnffordd.

5. Ni chaiff neb, yn ystod cyfnod y digwyddiad, gerdded ar y darn o’r gefnffordd.

Cymhwysyo

6. Nid yw’r gwaharddiadau yn erthyglau 3, 4 a 5 yn gymwys ond ar yr adegau hynny ac i’r graddau hynny y bydd arwyddion traffig yn eu dangos.

Interpretation

2. In this Order—

“exempted vehicle” (“*cerbyd esempt*”) means—

- (i) any vehicle being used for police, fire or ambulance services purposes;
- (ii) any vehicle being used in connection with works to the road or lighting or traffic signs or emergency works to any sewer or to any main or apparatus for the supply of gas, water or electricity, or telecommunications in, or in any land adjacent to, a length of road concerned;
- (iii) any vehicle used by an authorised event official in support of and for reasons of the safety of the relevant event;

“event period” (“*cyfnod y digwyddiad*”) means that period commencing at 09:00 hours on 3 March 2024 and ending when the temporary traffic signs are permanently removed;

“the trunk road” (“*y gefnffordd*”) means the A5 London to Holyhead trunk road that extends from its junction with Holyhead Road Roundabout (Antelope Inn), Bangor, Gwynedd to its junction with Mona Road Roundabout (Shell Garage), Menai Bridge, Anglesey.

Prohibition

3. No person may, during the event period, drive any vehicle, other than an exempted vehicle, on the length of the trunk road.

4. No person may, during the event period, ride any pedal cycle on the length of the trunk road.

5. No pedestrian may, during the event period, proceed on the length of the trunk road.

Application

6. The prohibitions in articles 3, 4 and 5 apply only during such times and to such extent as indicated by traffic signs.

7. Bydd y Gorchymyn hwn yn para am 1 diwrnod ar y mwyaf.
