Thank you for your request which I received on 6 January 2024. You asked for the following information, further to your previous request ATISN 18808:

Total fuel usage by all Welsh Government (WG) ministers on a yearly basis from 2015 onwards. All emissions from car, air, land and sea travel. There was reference to 'WG emissions reporting'. I request full details and information on this also.

In the WG public engagement strategy for 2023-2026 it was stated that there needs to be 'visibility' about how the WG is 'leading by example and acting with openness, honesty and integrity.'

How is this statement reconcilable with the fact that there are currently 12 official cars available for use of WG ministers at a cost of £474 for 2022-2023? I refer to ATISN 18638.

Please supply the model, make and cost of each of these cars.
