Our response

From my preliminary assessment I estimate it will cost more than the appropriate limit set out in the Freedom of Information and Data Protection (Appropriate Limit and Fees) Regulations 2004 to answer your request. The appropriate limit specified for central government is £600. This represents the estimated cost of it taking over 24 hours of time to determine whether we hold the information and to thereafter locate, retrieve and extract it.

Your request asks about 48 different bodies. In approaching policy divisions that hold data on these, I ascertained that much of the information is available, for instance at Companies House. See, for instance, CARDIFF INTERNATIONAL AIRPORT
LIMITED. Or published in annual reports. For instance, Natural Resources annual report and accounts 2022 23, or the RCAHMW-Annual-Report-2022-23.pdf. Such published information is exempt from disclosure under FOIA Section 21 (Information accessible by another means), but for each of the 48 policy areas you ask about, work needs to carried out to do both of the following:

- Locate published information and review it to see to what extent your questions are answered.
- 2. Locate and extract the information that is not published.

The first task is relatively easy where officials are aware of what is published, but still took at least 15 minutes to both locate and review the information. The second task, however, took longer. Where a division has the information to hand, it would take 15 minutes to locate, extract and review information for release, but in a sample exercise of eight policy divisions, estimates of time taken required to do this work estimated from 15 minutes (where information was to hand) to four-five hours (where queries of our finance system were required). Based on a sample average of 2 hours

work per body, I find that it would take 96 hours of work to collate and extract the information you have requested. It is therefore withheld.

It is very likely that we would not hold some of the requested information, and for bodies outside of Welsh Government and not managed by us, to obtain all the information you require, you should approach these directly. Care Inspectorate Wales, Healthcare Inspectorate Wales, Planning and Environment Decisions Wales, however, are just parts of Welsh Government.

Next steps

If you are dissatisfied with the Welsh Government's handling of your request, you can ask for an internal review within 40 working days of the date of this response. Requests for an internal review should be addressed to the Welsh Government's Freedom of Information Officer at:
