#### Treatment of tourism influenced by COVID-19 in the 2023-24 settlement

#### **Summary**

 This paper looks at tourism data used in the calculation of the local government settlement where the distribution could have been impacted as a result of the COVID-19 pandemic.

#### **Background**

3. The local government settlement formula uses a number of datasets which will have been influenced by the COVID-19 pandemic. This paper looks at the tourism data and allows DSG to consider the treatment of this dataset for the 2023-24 Settlement.

#### **Analysis**

#### Tourism data used in the enhanced population indicator

- 4. The 2021 *tourism data* continues to *include AirBnb* stays (as agreed in the DSG (2021) paper 3). DSG decided to freeze the 2019 tourism data for the 2022-23 settlement and not use the 2020 tourism data Tourism data is used within the *enhanced population indicator* to proxy the additional population of visitors to each local area.
- 5. Table 1 provides an exemplification to the 2022-23 Settlement of the 2021 tourism data. The most significant change can be seen for Cardiff showing a decrease of more than £1m. Table 2 compares the 2021 tourism data against the current 2019 tourism data frozen and used for the 2022-23 settlement and Table 3 shows the impact on the Enhanced population of updating the tourism data.

#### Conclusion

 DSG are asked to consider this dataset, noting that the data is used to proxy the average number of visitors in each area on any given day and whether the data should be updated with the 2021 tourism data or remain frozen with the 2019 data. DSG should

also consider from their local knowledge whether this data will revert back to the historic pattern.
