### **Unemployment Benefits data**

### Summary

 This paper sets out the latest position concerning the most recent unemployment benefits datasets and the potential impact on the 2023-24 Local Government Settlement.

## **Views Sought**

2. The DSG are asked to consider the unemployment benefits datasets and outline their views for the 2023-24 settlement.

# **Background**

- Benefits data are used as proxies for deprivation in Settlement indicators to distribute funding, through a combination of unemployment benefits data sets (Income Support, JSA, Pension Credit and Universal Credit (UC) not in employment) for all ages or working age; and disability related benefits (PIP, SDA, DLA).
- 4. Due to the seasonal and covid volatility in this data a 12-quarter average was agreed through DSG in the past and is used within the settlement to smooth the year-on year changes, with 4 quarters of the 12 being updated each settlement year.
- 5. On 1 April 2013, the <u>Council Tax Reduction Scheme (CTRS)</u> replaced Council Tax Benefit (CTB) in Wales and eligible households were automatically transferred onto the new scheme. The CTRS Regulations were closely based on previous CTB rules. This ensured households retained their entitlement to support in meeting their council tax liability. We have amended the original Regulations each year since to maintain entitlements.

## **Analysis**

Table 1 in Annex A shows the underlying average of 12 quarters data by different benefit combinations. Generally, this follows recent trends that income support, jobseeker allowance, and pensions credit claimants have decreased over the past

few years as changes to the benefit system of the employment-based benefits are gradually moving from these legacy benefits onto universal credit. Overall all local authorities have seen a gradual increase in claimants.

7. Table 4 in Annex C shows the CTRS expenditure and caseload data. Overall most local authorities have seen a increases in CTRS expenditure but decreases in CTRS caseload.

# Distributional impact of updating the data

- Table 3 in Annex B provides an exemplification of the latest benefits data on the 2022-23 settlement. Overall the distributional impact in AEF is relatively small with the largest decreases Neath Port Talbot (£0.23m) and Rhonda Cynon Taf (£0.16m).
- 9. Table 5 in Annex D provides an exemplification of the latest benefits data and CTRS on the 2022-23 settlement. Overall the largest decreases can be seen in Neath Port Talbot (£0.41m) and Bridgend (£0.37m).

#### Recommendation

10. Continue to use this indicator as a proxy for deprivation similar to how it was used for the settlement in 2022-23 as the distributional impacts are minimal.
